NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the 03 of March 2024 at 2:16 at 6725 HELMSLEY CIR, WINDERMERE, FL, 34786 (Zone: 307) in Orange County did

On March 3rd, 2024, at approximately 0149 hours, I, Deputy Westendorf responded to 6725 Helmsley Circle, Windermere, Florida 34786, in reference to a possible battery, later found to be a domestic battery. One adult male was arrested for Battery (Dating Violence) and transported to the Orange County Booking and Release Center without incident. My investigation revealed the following: Describe Relationship: Jacqueline Sawyer and Clive Mason have been in a romantic dating relationship for approximately eleven years. Jacqueline and Clive reside together in the same residence as a family. Children present: No children present. Describe Injuries: No injuries observed to either party. Other evidence obtained: Written sworn statement was obtained from Jacqueline. If suspect was not arrested, why?: N/A. Is there an injunction for protection order in place: There is no known injunction for protection order in place. History of domestic violence: Jacqueline advised Mason has battered her in the past. Upon arrival, I made contact with the complainant, identified via her Florida Driver License as Jacqueline Sawyer. Jacqueline stated the following verbally. Jacqueline stated her boyfriend, Clive Mason, pushed her during an argument. Jacqueline stated Clive has been drinking and he becomes angry and combative when he is intoxicated. Jacqueline noted the argument was about wanting Clive to leave the residence. During the argument, Clive pushed Jacqueline on her upper chest in their kitchen against their fridge and cabinets. Clive then went outside to smoke a cigarette which is when Jacqueline called law enforcement. I then spoke with Clive who stated he grabbed Jacqueline to calm her down because she was intoxicated and yelling. Clive denied pushing Jacqueline or hurting her in any way. Clive stated they have been in a romantic dating relationship for approximately eleven years. I observed no injuries on either party. Deputy Conerly and Deputy Harrison obtained a written sworn statement from Jacqueline in addition to completing domestic violence paperwork. Jacqueline invoked her right to remain confidential under Marsy's law. Based on Jacqueline's verbal and written sworn statement, probable cause was developed to charge Clive Mason with Battery (Dating Violence) FSS. 784.03-15. Clive was arrested and transported to the Orange County Booking and Release Center without incident.
