On the 10 day of July, 2023 at 16:09 (Specifically include facts constituting cause for arrest.)

I responded to 185-217 E Indiantown Rd. (Hong Kong Wok N Grill) in reference to deadly threats. Upon arrival, I made contact with Michelle Chen (W/F 1/26/2003) who told me the following: Michelle, who's family owns the restaraunt, stated that at approximately 1530 hours, she received a video pertaining deadly threats from an ex-employee, Coco Resch (5/24/72). The video appeared to have been made from the county jail parking lot. The video, being recorded by her and showed her with the jail in the back ground. The video showed her making statements in Chinese pertaining to her just being released from jail and showed all her release paperwork. The video then showed her make the following statement: "Remember this face, at 4:30 pm, I am coming with a gun, I don't care what race you are, I am coming to shoot all at Hong Kong Grill". Michelle said Coco is not in a good frame of mind and was fired and trespassed from the property on 7/8/23. She said Coco has been making threats to her and her family since. Michelle said she and her family are in fear of Coco and believe she will do harm. Coco was arrested on 7/8/23 for trespass after warning and again on 7/9/23 for trespass after warning.

A sworn statement was obtained from Michelle via BWC and wished to press charges. An email was obtained and a link was sent for video and text threats to be uploaded to Evidence.com.

Based on my investigation, Coco is charged with Written or electronic threats to kill, do bodily injury or conduct a mass shooting per F.S.S. 836.10.
