

<p><input checked="" type="checkbox"/> Marsy's Law CVI FL. Const. Art.1 § 16(b)</p> <p>On October 1, 2025, at approximately 1837 hours, I was dispatched to [REDACTED] in [REDACTED]. I responded to a call for service regarding a domestic disturbance, which was later reclassified to a simple battery domestic.</p> <p>Upon arrival, contact was made with the complainant, Bridgette O Kohn, who appeared visibly upset while crying. Bridgette, reported that her husband, Cody L Kohn, had physically assaulted her by throwing objects and striking her.</p> <p>Bridgette stated that the incident began while her 14-year-old son Connor J Kohn (W/M DOB: [REDACTED]) was doing his homework at the dining table, and she, her husband, and their youngest child Cooper T Kohn were in the backyard. She explained that her youngest child, Cooper Kohn (W/M DOB: [REDACTED]) slipped and hit his head on the tile while running, which led to her husband Cody, blaming her for the incident. Bridgette reported that Cody closed the back door, preventing her from entering the house with Cooper, the injured child. Once inside, Cody allegedly began yelling at her and threw a red meat thermometer at her face, striking her on the right side near her hairline.</p> <p>Bridgette further stated that Cody retrieved another red meat thermometer and threw it at the back of her head while she was seated on the couch. She also alleged that Cody struck her on the right side of the back of her head with a closed fist. Bridgette expressed concern about the incident occurring in front of her children, particularly her 14-year-old son Connor, who was present at the dining table during the altercation. She mentioned that this behavior had occurred before and attributed Cody's aggression to his use of testosterone. Bridgette stated that Connor witnessed the incident, while the younger children Cody W Kohn Sr. (W/M DOB: [REDACTED]) were not directly involved. Bridgette declined medical attention for herself and her children but expressed a desire to press charges against Cody. She also indicated that Cody had access to another residence nearby.</p>

Art.1 § 16(b)</p> <p>I then made contact with Cody Kohn, who provided his account of the incident. Cody stated that he was grilling chicken in the backyard when the youngest child Cooper fell and injured himself. He claimed that Bridgette began yelling at him, accusing him of leaving a meat thermometer out, which she believed caused the child to fall. Cody admitted to throwing a meat thermometer but denied hitting Bridgette or physically assaulting her. He stated that his 14-year-old son Connor was present and could corroborate his version of events.</p> <p>Cody expressed frustration about the situation and mentioned that similar incidents had occurred in the past. He denied having access to the Ring camera system, which he claimed Bridgette had removed access to him. Cody also inquired about the process and whether he would be required to leave the residence.</p> <p>I interviewed the 14-year-old son, Connor, who confirmed witnessing parts of the incident. Connor stated that he saw his parents arguing and observed Cody throwing a meat thermometer, but did not see the object strike Bridgette. He also mentioned that he was focused on his homework during the altercation.</p> <p>Based upon my investigation, probable cause exists against Cody L Kohn with simple battery under F.S.S. 784.03(1A1), for intentionally hitting Brigette O Kohn to the right side of her face and the right rear of her head with a red meat thermometer against her will for domestic violence.</p>
