The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the listed date and time, Deputy Moncada (ABN:263280) observed a blue BMW sedan bearing FL Tag: 20ATAV parked at 10603 Sheldon Rd. Upon coming closer to the vehicle, she observed the defendant/sole occupant passed out in the driver's seat with the vehicle in drive. Deputy Moncada observed the driver had the keys in his pocket in actual and physical control of the vehicle. She observed signs of impairment from the defendant and requested a DUI investigator.

Upon initial contact with the defendant, I detected the strong odor of an alcoholic beverage emanating from the defendant's breath and observed his eyes to be red/bloodshot/glassy and watery, his speech to be slurred, and his balance to be unsteady. I requested the defendant to perform the Standardized Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairments, and he was subsequently arrested for DUI. Upon arrival at CBT, the defendant refused to provide two lawful samples of his breath. I read implied consent to the defendant at approximately 0550 hours, to which he understood, at which point the defendant refused to provide a lawful sample of his breath. The defendant was positively identified via his Florida driver's license.
