




	On 09/08/2024 at approximately 0127 hours, JPD Officers were dispatched to a welfare check at 738 E Indiantown Rd. (Taco Bell) in the Town of Jupiter, Palm Beach County, Florida.									
	The caller advised a green Land Rover Defender was driving in the drive-thru of Taco Bell, running over curbs. The caller reported the vehicle was being driven by a white male, wearing a collared shirt and shorts, approximately in his mid-30s. The caller wished to remain anonymous, but was concerned enough to advise that they believed the driver in the Land Rover was under the influence.									
	I was clearing up a crash while training Officer DiTommaso. As soon as we cleared the crash scene, we responded in my unmarked Jupiter Police Department patrol vehicle (vehicle 1911), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.									
S T A T E M E N T	Upon arrival, I made contact with PFC Schneider (the first Officer on scene). PFC Schneider advised me of the following: Upon arrival, he observed a black Land Rover Defender bearing FL tag # 93DTQ parked (facing south) in the parking lot. The vehicle was located blocking the travel lanes of the parking lot and not parked in a parking space. The vehicle was approximately 150 feet south of the Taco Bell with the window rolled down. PFC Schneider made contact with the male and sole-occupant of the vehicle who was seated in the driver's seat. PFC Schneider identified the male to be Collin Lachapelle (w/m; 05/23/1989; FL DL # L-214-112-89-183-0) by his valid Class E Florida driver license. PFC Schneider advised Lachapelle had bloodshot/glassy eyes, slurred speech, the odor of an unknown alcoholic beverage on his breath, and overall appeared heavily intoxicated. <p>of the vehicle was stopped touching the raised concrete curb, in front of a fire hydrant. The vehicle appeared to have attempted to pull into a parking space nearby, but didn't make it and was now blocking the travel lanes in the parking lot. I observed Lachapelle sitting in the driver seat of the vehicle and the vehicle appeared to be off. I immediately observed Lachapelle had droopy, extremely bloodshot/glassy eyes. I made contact with Lachapelle and noted his speech was heavily slurred. While I spoke to Lachapelle, I could smell the overwhelmingly intense odor of an unknown alcoholic beverage on his breath which intensified when he spoke to me. Lachapelle also had ketchup and various pieces of food smeared all around his mouth. Lachapelle was wearing a collared shirt, shorts, and appeared to be approximately in his mid-30s, as the caller advised.</p> <p>Lachapelle advised me that he had been out at a wildlife management area earlier in the day. I requested Lachapelle exit the vehicle and it appeared as though he was reaching around, trying to put the vehicle in park, and having trouble finding the door handle. When Lachapelle exited the vehicle, it appeared as though he was very unsteady on his feet and was swaying from side to side and front to back while standing still. Lachapelle had ketchup and various food stains on his shirt and pants. Lachapelle advised he consumed 2 drinks earlier in the day, that he could not feel the effects of the alcohol, that he did not feel under the influence, or even feel buzzed.</p> <p>Lachapelle advised he did not have any medical conditions and that he did not take any medications. I asked if Lachapelle was willing to perform some tasks to help me feel better about him driving home. Lachapelle agreed.</p> <p>I directed Lachapelle to a nearby parking line and observed he was very unsteady when he walked. I provided the instructions for the Horizontal Gaze Nystagmus task to Lachapelle and he continually looked around throughout the entire approximately 10 minutes I attempted to give him these instructions. The way Lachapelle looked around gave me the impression he was looking for an avenue to potentially start fleeing on foot, but he never did. I am a certified Drug Recognition Expert (IACP # 32395) and I attempted to conduct this task in accordance with my training. I observed Lachapelle had pupils of equal approximate size and he did not have resting nystagmus.</p> <p>When I began moving my stimulus to Lachapelle's left to check for equal tracking, Lachapelle did not move his eyes. I attempted multiple times to have Lachapelle move his eyes, but his gaze remained fixated straight ahead, with a blank stare, staring through me. Lachapelle advised me that I had told him to look at me, instead of my stimulus. I corrected Lachapelle and advised him to follow the stimulus and not look at me. I attempted several more times to instruct Lachapelle to follow the stimulus with his eyes but the only thing he would do is look straight ahead.</p> <p>I advised Lachapelle that I needed him to listen to my instructions very carefully and</p>

Lachapelle advised he understood and wished to continue. I spent several more minutes attempting to instruct Lachapelle to follow the stimulus. Lachapelle appeared uninterested in me talking to him and looked to his left and right, or "dead eyed" straight ahead at me. After multiple unsuccessful attempts to provide Lachapelle with the instructions for him to properly complete the Horizontal Gaze Nystagmus task, I determined that Lachapelle was either unwilling or far too intoxicated to properly perform the task and I placed him under arrest for DUI.</p> <p>I secured Lachapelle in handcuffs which I checked for proper spacing and double-locked. When I sat Lachapelle in the rear passenger seat of my patrol car I asked if he felt as though he would vomit and he advised he would. I requested at roadside that Lachapelle provide a lawful sample of his breath for the purpose of determining the alcohol content. Lachapelle did not understand me and I asked him for a breath test in simpler terms. Lachapelle refused. I read Lachapelle Implied Consent from a prepared test, confirmed he understood, and again requested he provide a breath sample. Lachapelle refused at 0209 hours.</p> <p>Based upon the aforementioned facts resulting from my investigation, I find Probable Cause exists to charge Collin Lachapelle with DUI - Normal Faculties Impaired pursuant to FSS 316.193 (1) (a) .</p>
