


Body worn camera was used.</p> <p>This Officer visually estimated the vehicle to be traveling approximately 60 MPH in a posted 45 MPH zone. Using RADAR Scout (SHD-04626), this Officer received a steady doppler tone and reading of 60 MPH. The RADAR calibration was last checked on 11/05/2024 and was due on 05/05/2025. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer entered the same lane as the vehicle, a Volkswagen (42BJDX/FL) and initiated a traffic stop on same at 3800 Northlake Blvd, PBG, FL.</p> <p>This Officer approached the driver window and made contact with the sole occupant, later identified via Florida Driver License photo on DAVID, Connor McCool (OF), while he was still in actual physical control of same. McCool initially identified himself via a photo of his US Passport on his phone. This Officer was able to locate McCool's driver license information on FCIC, which showed it as suspended 04/03/2025. While speaking with McCool this Officer observed him to have watery eyes, low heavy eyelids, thick slurred speech, and the obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. This Officer also noticed an open Michelob Ultra glass bottle in the center console. McCool was seemingly unaware of the recent suspension on his license. McCool stated he was coming from a friends' house in Gardens and was going to stop at Taco Bell on the way home. This Officer asked McCool how much he had to drink, citing the beer in plain view. McCool looked at the beer and then said he had not drank. This Officer again pointed out the beer and asked McCool again,</p>

to which he replied "about a beer or two". McCool denied consuming Cannabis and/or Narcotics on this night. McCool said he felt fine and said he was not sick or injured.

Based on this Officer's observations, this Officer expressed concern to McCool about him being under the influence and asked him to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he slowly complied. McCool indicated a leg condition which would affect the exercises, thus seated exercises were conducted while McCool was seated in his lift gate trunk.

The first exercise conducted was the Horizontal Gaze Nystagmus. The stimulus used was a Streamlight Stylus with an illuminated red tip. McCool had a lack of smooth pursuit in both eyes as well as involuntary jerking at maximum deviation in both eyes. McCool also had the onset of Nystagmus in both eyes prior to 45 degrees as well as Vertical Gaze Nystagmus in both eyes.

The second exercise conducted was the Finger to Nose. During the exercise, the following was observed: First command of Left, he touched with the pad of his finger and had to be told to lower his hand. First command of Right, he again touched with the pad of his finger and had to be told to lower his hand. McCool also tilted his head forward. Second command of Left and second command of Right, he touched with the pad of his finger. Third command of Right he touched with the pad of his finger, tilted his head forward and opened his eyes. Final command of Left, he touched with the pad of his finger.

The third exercise conducted was the Palm Pat. This Officer explained the exercise three times to McCool while he was at times argumentative about the reason for the exercise. McCool started the exercise prior to being told to do so at least twice. During the exercise, McCool had to be told to increase speed and also stopped prior to being told to do so.

The fourth exercise conducted was the Hand Coordination. During Task 1, McCool rolled his fists. During Task 2, McCool clapped four times rather than three.

The fifth exercise conducted was the Modified Rhomberg Balance. McCool estimated the passage of 30 seconds in approximately 37 seconds.

The final exercise conducted was the Rhomberg Balance. This Officer explained the exercise twice to McCool while he again argued the reason for the exercise. McCool recited the alphabet A through R, then X, then T,U,V,W,Y,W,X,Y,Z.

Based on this Officer's observations, McCool was placed under arrest at 0347 hours. During a tow inventory, this Officer inspected the beer in the center console cup holder. The beer was cool to the touch as if just removed from refrigeration. The beer

was more than halfway full of a liquid which smelled like an alcoholic beverage.

At PBSO BAT this Officer conducted a 20 minute observation period noting no issues. This Officer requested McCool provide a breath sample for the purpose of determining its alcohol content, to which he refused. This Officer read Florida Implied Consent to McCool to which he acknowledged and refused at 0433 hours. It should be noted, McCool has a prior sobriety test refusal dated 12/18/2015, in this county.



Based on the results of the investigation, this Officer has probable cause to charge Connor McCool with driving under the influence to the extent his normal faculties were impaired, in violation of FSS 316.193(1)(A). McCool refused to submit to a lawful sobriety test with a prior refusal, in violation of FSS 316.1939(1).

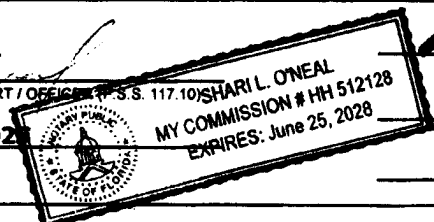



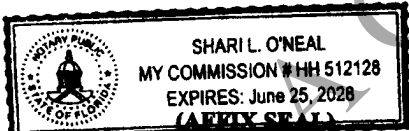
