 On the 9 day of October, 2025 at 02:54 (Specifically include facts constituting cause for arrest.)

On Thursday, October 9th, 2025, at approximately 0227 hours, I was on proactive patrol in Jupiter West Plaza (6671 W Indiantown Rd., Jupiter, FL). I observed a dark blue Chevy car with the lights off, engine running, and fogged windows facing southbound in a parking spot. This parking spot was at the southernmost point of the plaza. All of the above listed reasons are common with individuals sleeping in their vehicle which is a violation of Jupiter Town ordinance 11.4 Unlawful to Lodge on Private Lands Without Consent, "It shall be unlawful for any person to willfully lodge upon the private lands of another within the town without having been authorized, licensed or invited to do so by the owner, lessee or authorized agent of such property. I parked my fully marked Jupiter Police vehicle approximately three car lengths behind this vehicle, as to not block it in, and approached the vehicle. As I approached the vehicle, I observed several items of trash around the driver's side door, which is also a common sign of an individual being in their car.

Upon my arrival at the driver's side door, I observed a female, later identified as Cora J. Distel (W/F, DOB 09-23-2004), sleeping in the driver's seat with her phone propped up on the steering wheel, playing a video. I knocked on the door several times and announced myself as a police officer, while also shining my flashlight on my Jupiter Police patch. Distel woke up and opened the driver's door, where I observed three clear vials with a yellow oily residue inside. Based on my training and experience, I recognized these to be THC oil vape cartridges. Ofc. C. Banegas, who was familiar with Distel, asked if she still smoked marijuana. Distel replied yes, while pointing at the THC cartridges in her door. I requested that Distel exit the vehicle, which she did without incident. I asked Distel if I could search the vehicle, to which she replied yes. I asked if I was going to find anything else in the vehicle, to which she responded, maybe a little bit of weed, and half a Xanax pill (alprazolam) in a prescription bottle that was not for that pill, which would be inside her purse on the front passenger seat. The search of the vehicle provided the following items:

Inside Distel's purse, a clear plastic bag containing a green leafy substance (which later field tested positive for marijuana) was located, as well as a prescription bottle in her name and labeled for Aripirazole 5mg. Inside the bottle were four different types of pills. These pills were later identified through Drugs.com (Pill Identifier) to be half a Trazodone pill, a small white circular pill labeled 13 PPW 0.12 grams; one Gabapentin pill, white capsule labeled 103 PPW 0.18 grams; half an Oxycodone pill, a blue circular pill labeled 9 PPW 0.06 grams; and half a Xanax pill, white in color and rectangular labeled 2 and 4 PPW 0.11 grams.



A separate prescription marked for Tramadol 50mg bottle was located inside of the glove box, which contained three different types of pills. These pills were also later identified to be one Tramadol pill, white oval shape labeled ET50 PPW 0.23 grams; two Aripirazole pills, white round shape labeled 5 on one side and 17 on the other PPW 0.12 grams; and two Hydroxychloroquine oblong pills labeled ZC38 PPW 0.67. On the center console, inside of a black purse wallet, were three full Naloxon film packets, and one empty one. Also on the center console was a THC vape with a yellow oily liquid inside.

Inside of the fuse box, a white cylinder container labeled Reef Cannabis was located. Next to it, a small clear plastic bag containing a green leafy substance (later field tested positive for marijuana) was located. On both the passenger door pocket, as well as the driver's side, two Select vapes were located with a yellow oily liquid inside.

After I located the prescription bottle and the marijuana, I advised Distel of her Miranda Rights, which she understood. I asked Distel where she obtained the pills from, and she replied that she met a guy on Telegram and they exchanged Snapchats in order to buy Xanax so she could sleep easier. Distel then met up with the unknown white male where he stated that he would only sell her \$100.00 worth of product or else he wouldn't sell to her. Distel bought the product and was then blocked on Snapchat. Distel advised that she does not have any information on the known white male. I also asked Distel if she had a prescription for any of the pills, to which she replied no.

Distel was placed into handcuffs which were checked for proper spacing and double locked. A search on scene was conducted by Ofc. Raleigh, and then placed into the back of my patrol vehicle. Distel was transported to the Jupiter Police Department so the necessary paperwork could be completed, and then to the Palm Beach County Jail without incident.

Based on the aforementioned events, I find probable cause to arrest and charge Cora J. Distel with Possession of a TCH vape pen pursuant to F.S.S. 893.13(6) (A), because she was unlawfully and knowingly in possession of the THC vape; Possession of Xanax pursuant to F.S.S. 893.13(6) (A), because she was unlawfully and knowingly in possession of the Xanax pill; possession of Oxycodone pursuant to F.S.S. 893.13(6) (A), because she was
