CRIMINAL REPORT AFFIDAVIT/ HILLSBOROUGH COUNTY, FLORIDA

CRA #: TP24003095

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 02/26/2024 at approximately 0249 hours, I observed a black Mercedes sedan, bearing FL Tag "B9LID", traveling south on S West Shore Blvd approaching W Swann Ave at a high rate of speed. I estimated the vehicle's speed to be 52 MPH in a posted 30 MPH zone and the speed was confirmed via my Stalker Dual DSR Radar (SN D530871).

I conducted a traffic stop at the intersection of S West Shore Blvd / Culbreath Isles Dr and contacted the driver/defendant, identified via Florida Driver's License as Crystal Richardson. The defendant stated that she was coming from a friend's house where she had picked up her dog and was going home. During the initial contact, the defendant displayed multiple indicators of impairment to include, slurred speech, glassy eyes and a very strong odor of alcohol being emitted from her breath as she spoke. As the defendant exited the vehicle, she immediately said that she wasn't doing anything without her lawyer present. As the defendant spoke, I continued to detect a strong odor of alcohol from her breath, and when asked how much she had to drink prior to driving she responded, "Doesn't matter".

The defendant participated in the HGN exercise which resulted in 6/6 clues of impairment. When asked, the defendant stated she would not participate in any further exercises and although given several opportunities to participate, she refused. Due to the totality of the circumstances, the defendant was placed under arrest for DUI and transported to Central Breath Testing. Once at Central Breath Testing, the defendant was read implied consent however refused to provide an answer. Following a 20-minute observation, the defendant was seated at an instrument and given an opportunity to provide a breath sample and she verbally refused.

A D.A.V.I.D query of the defendant's driver's license showed a prior refusal on 09/13/2012 reference: REFUSE SUBMIT BREATH/URINE/BLOOD TEST : Citation/Case #: 5472XGA.

The defendant was issued the following citations: AF0FK2E - DUI AIUKNME - Refuse to Submit to Testing AIUKNFE - Unlawful Speed

The defendant was positively identified via Florida Driver's License.
