<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above-listed date and time, near the intersection of S Us Highway 41 / Gibsonton Dr., I responded to a reckless driver call for service, where the complainant was following a vehicle that was unable to maintain its lane and driving without headlights on. Upon locating the vehicle driving southbound on S Us Highway 41 towards Gibsonton Dr, I observed the vehicle driving without headlights on. Once directly behind the vehicle, I observed it to be a 2007 silver Aston Martin bearing FL tag QYQZ79. I further observed the vehicle swerving on the roadway, and crossing the white solid fog line on the left side several times. Based on the erratic driving pattern, I believed the driver was ill, sick, tired, impaired, or the vehicle had a mechanical issue and I conducted a traffic stop on the vehicle. Upon making contact with the driver, I immediately observed signs of impairment to include bloodshot watery glassy eyes, extremely slurred speech at times while talking, he was extremely unsteady on his feet, and the odor of an alcoholic beverage on his breath, which grew stronger as he spoke. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples after a 20-minute observation (.267/.247 BrAC). The defendant admitted to drinking an alcoholic beverage prior to driving. The defendant was identified by his Florida driver's license.</p>
