I exited my marked North Palm Beach Police patrol vehicle, in my issued North Palm Beach Police uniform to make contact with the male. I woke the male and informed him that he was violating North Palm Beach ordinance by sleeping outside. I requested the male's ID to which he told me that he did not have one. The male began to question why I stopped him and was attempting to identify him. I again explained the ordinance and told him that I needed to identify him as part of the investigation. The male identified himself as Dane R. Trumbore (03/03/88, At Large from California). Trumbore again asked if he was free to leave, to which I told him that he was not, at that moment.</p> <p>I explained to Trumbore that as long as he did not have any warrants, he would be free to leave. Trumbore appeared anxious and eager to leave. After a few minutes, while still waiting for Trumbore's information to be returned, Police Officers Bussek and Boardman arrived as my backup officers. Upon sight of the officers getting out of their vehicles, Trumbore said "Fuck this!" and took off running. PO Bussek and I were able to catch up with Trumbore as he began to cut through the shrubbery that separates the plaza from sidewalk that runs along US Hwy 1. As we attempted to restrain Trumbore, he continued to resist our efforts by attempting to pull away his arms and still trying to run away. We attempted to take Trumbore to the ground but were stopped by the shrubbery. A second attempt to go to the ground was successful and PO's Bussek and Boardman were able to secure Trumbore's arms and ultimately place him in handcuffs.</p> <p>Once the Trumbore was under control, he was assisted up and checked for injuries. Trumbore sustained a small scratch to his left cheek. The handcuffs were double check for proper fit and spacing and double locked. Trumbore was thoroughly searched before being placed in the rear of PO Boardman's vehicle. PO Boardman searched the prisoner compartment before and after transport, and no contraband was discovered. Trumbore because he did resist, obstruct or oppose Police Sergeant Ciezak, a law enforcement officer of the North Palm Beach Police Department, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.</p> <p>Due to the scratch on his face, Trumbore was transported to Palm Beach Gardens ER for medical clearance. Once he was cleared and other processing complete, Trumbore was transported to county jail without incident. He was turned over to jail personnel.</p> <p>The scratch was photographed and sent to records for the case file. No further information at this time.</p>
