The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 The defendant was driving a black 2024 Ford Expedition westbound on W Kennedy Blvd at a high rate of speed, when he passed me in the left lane. After catching up to the vehicle and pacing behind it, I observed a speed of 70 MPH. This section of W Kennedy Blvd is a posted 40 MPH speed zone.

During the traffic stop for the speeding infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, slurred speech, fumbling fingers, confusion with his vehicle paperwork, poor balance, he admitted to drinking wine prior to driving, and he emitted a distinct odor of an alcoholic beverage from his breath as he spoke.

The defendant was arrested for DUI following a display of 6/6 HGN + VGN and a refusal to participate in any additional SFSEs.

While at CBT, the defendant refused to submit to a breath test, despite being read Implied Consent.
