



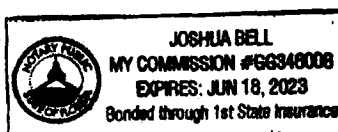

D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Friday January 13, 2023 at approximately 0019hrs I responded to 10651 Southern Blvd, Royal Palm Beach, FL 33411 in reference to a DUI investigation. Upon arrival I spoke with Sgt. Ponce #9368 that advised the following: On 01/13/2023 at approximately 23:15hrs, I was driving West bound on Southern Blvd and observed a black pickup truck traveling East bound in the West bound lane almost striking vehicles. I called 911 to report a possible drunk driver in the area located in the City of West Palm Beach unincorporated Palm Beach County, Florida. I turned my vehicle around and headed East bound to maintain a visual of the vehicle which was still heading East bound in the West bound lane for approximately 3/4 of a mile. The driver proceeded to cross over into the East bound lane and stopped at a traffic light. I pulled up beside the black GMC truck bearing FL tag YIORS and observed a white male later identified as Jusino Daniel Eric, by his Florida Drivers License. I attempted to get the situation of the subject, so he could safely pull his vehicle over. To no avail. The subject made a left turn and headed West bound on Southern Blvd maintaining a speed of 50 to 55 mph and was unable to maintain a lane. I continued to follow the vehicle West bound and he turned into the ORA parking lot, circled the building, and proceeded to turn West bound on Southern Blvd. I maintain a visual of the vehicle that proceeded to turn into the 7Eleven at 10651 Southern Blvd, Royal Palm Beach, FL parking lot where he came to a complete stop. Palm Beach County Deputy Sheriff's Singer and Ebel arrived. The scene was turned over and I had no further involvement. I also spoke with DVS Singer #36149 who stated the following: On 01/13/2023 at approximately 23:15hrs, I responded to a call of a wrong way driver, who was driving eastbound in the westbound lanes of Southern Blvd in the area of SR-7. While en route dispatch received a second call from off duty Palm Beach County Sheriff's Office Sergeant Steven Ponce #9368 (reference supplement Probable Cause) who was given updates on the vehicle a black GMC truck bearing FL tag YIORS and the vehicles location. Sergeant Steven Ponce #9368 advised the vehicle stopped at the 7-11 located at 10651 Southern Blvd, Royal Palm Beach FL. Upon arrival, I made contact with the driver and sole occupant Daniel Jusino from the passenger side of the vehicle. Daniel was seated in the drivers seat with the engine still running and the vehicle in drive. I noticed there was a strong smell of an unknown alcoholic beverage coming from Daniel's vehicle. Daniel's eyes were blood shot and glassy and his speech was slurred. Daniel stated he was coming from a friends house and had nothing to drink.

OBSERVATION OF DRIVER:

I walked up to the driver, W/M Daniel Eric Jusino (12/09/82) that was standing outside of his vehicle. Jusino appeared disheveled and his zipper to his shorts was down. Jusino's eyes were red, watery, and glassy. As he spoke to me I immediately smelled a strong odor of an unknown alcoholic beverage coming from his breath/person. While standing in front of me I noticed that he was swaying from side to side and slurring some of his words.

DRIVER'S STATEMENTS:

Jusino said that he had only drank two Michelob Ultras earlier and that his last Michelob Ultra was at one hour prior to being stopped by the Deputies. When I asked him what his home address was he began to say it and slurred some words. Jusino said that he could not remember it at the time and he could not remember his phone number (later at the BAT he was able to recall both). Jusino did not know he was traveling east bound in the west bound lanes of Southern Blvd.

ODORS:

Jusino had a strong odor of an unknown alcoholic beverage coming from his breath/person.

GENERAL OBSERVATIONS

SPEECH: Slurred some of his words.

ATTITUDE: Uncooperative.

CLOTHING: Gray shirt, black shorts, and black shoes.

MEDICAL/OTHER: Take ADHD medicine and had knee surgery five to six months ago.

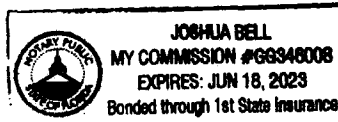

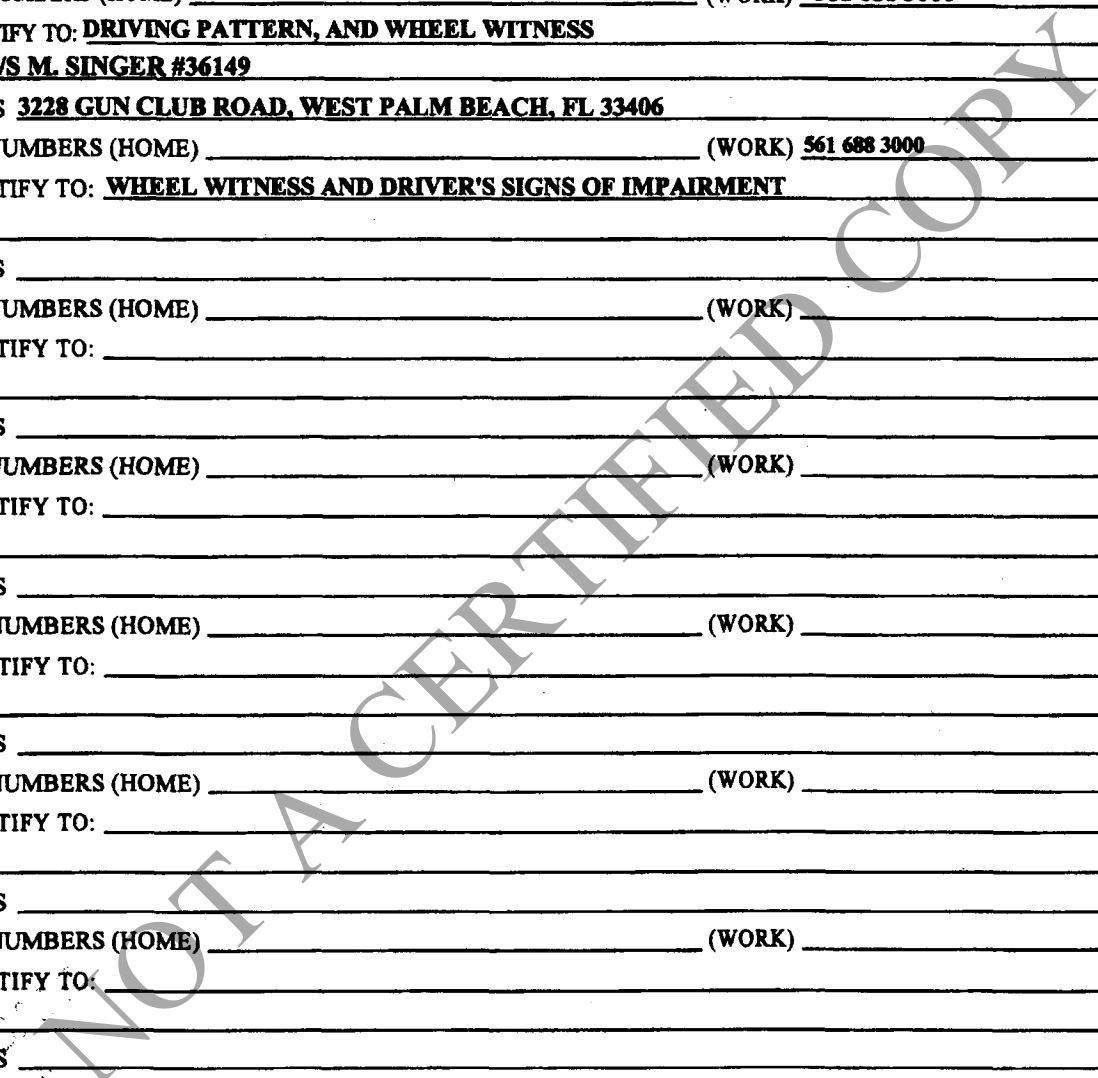
