On 8/18/2023 at approximately 1422 hrs, I was conducting traffic enforcement in the active 20 mile per hour school zone in front of Jerry Thomas Elementary School, located at 800 Maplewood Drive, Jupiter, Florida. I was acting in my capacity as a member of the Jupiter Police Department traffic unit. I observed a grey Toyota Tacoma northbound on Maplewood Drive approaching my position. I estimated the speed of the vehicle to be 30 MPH. I activated the reticule sight my certified Kustom Signals Pro Laser (SERIAL #LF08702) on the front bumper of the vehicle and received a speed readout of 31 miles per hour at 423 feet. The vehicle was moving too fast for me to step out in front of from my position. I entered my unmarked Dodge Charger, equipped with red/blue lights and siren and attempted a traffic stop on the Toyota north of the school. The vehicle was slow to stop and pulled into the Home Depot Parking lot, eventually pulling nose-in to a parking space. The driver opened his door and attempted to get out of the vehicle. I instructed him from my vehicle to stay in the car. The driver was identified by his Florida license as Daniel Murphy (OF-1, W/M 3/4/1969). It should be noted that at the time of this stop, your affiant is a Drug Recognition Expert (IACP #34042) in good standing and is also a certified SFST instructor.

While speaking to Murphy and explaining the reason for the stop I detected a strong odor of unknown alcoholic beverage emitting from his person, which intensified when he spoke. Murphy had slurred speech. I asked him how much he had to drink today and he said "nothing". I had Murphy exit the vehicle at this time to continue my investigation. I had Murphy remove his sunglasses. At this time I observed that he had glassy, bloodshot eyes. Murphy also had pupils that appeared to be constricted for the lighting conditions (pinpoint). While speaking to Murphy I wanted to see if he could follow my finger, which he had trouble doing. I asked him again if he had anything to drink and he said no. I asked him if he has taken any medications and he said "yes" and that he had just had surgery. He then lifted his shirt to show a healing bandaged surgical wound. I asked him what medications he took and he stated Ambien and an

Based on my investigation so far I had concerns that Murphy was possibly operating while impaired. I asked Murphy to rate himself on a scale of impairment from 1-10, with 10 being the most impaired. He advised he was a "1". He was unsure of the opiate dose he took, but stated it was 45 mg of Ambien. I asked for Murphy to participate in field sobriety exercises and he agreed.






I placed Murphy under arrest at 1435 hrs. Upon placing him under arrest, I asked Murphy if he would submit to a breath test. He refused. I read him implied consent from a prepared card and he advised that he understood. I again asked him if he would submit to a breath test and he again refused, with a marked refusal time of 1439 hrs. A check of Murphy in DAVID shows that he had a prior refusal to submit to a lawful test of breath, urine or blood on 12/15/2014. 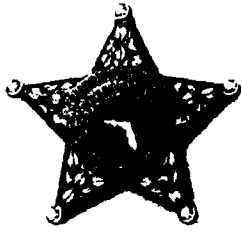
