On 06/16/2023 at approximately 0221 hours, I responded to the southbound Interstate 95 on-ramp from westbound S.R. 706 (W Indiantown Rd.) in the Town of Jupiter, Palm Beach County, Florida at the request of Corporal Banegas who was backup on a traffic stop conducted by Sergeant Cook. At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 2109), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.

Upon arrival, I made contact with Sergeant Cook who advised the following: he observed the violator's vehicle (a white Toyota SUV bearing FL tag # NSGL16) turning from 68th Terr N. onto S.R. 706. When the vehicle turned, the vehicle struck the raised concrete median barrier with both tires and traveled westbound on S.R. 706. The vehicle continued westbound, almost crashing into another vehicle as it changed lanes to enter the southbound on-ramp to Interstate 95 causing that other vehicle to brake and create distance between itself and the violator to avoid a crash. When Sergeant Cook activated his lights to conduct a traffic stop, the vehicle continued on the southbound Interstate 95 on-ramp and was slow to respond to the police vehicle behind it before it ultimately pulled over onto the right shoulder of the roadway and stopped. Sergeant Cook identified the driver of the vehicle to be Daniel Parton (w/m; 11/25/1976) by his valid Ohio driver license. Sergeant Cook advised Parton had slurred speech, poor dexterity, was fumbling with his documentation, dropping things in the vehicle, had the odor of an unknown alcoholic beverage on his breath, and appeared to have urinated himself. See supplement from Sergeant Cook.

I approached the vehicle on the driver side and requested Parton exit the car. Immediately, I could smell the strong odor of an unknown alcoholic beverage coming from the interior compartment of the Toyota. Additionally, Parton had a flushed face and dazed appearance (seeming to stare wide-eyed while looking around). Parton exited the


vehicle and I directed him to the shoulder of the roadway, behind his vehicle. Parton stumbled and used the vehicle to steady himself while walking. I also noted Parton had very slurred speech and I could smell the strong odor of an unknown alcoholic beverage coming from his breath as he spoke to me. Parton was wearing a collared shirt and blue jeans with a black belt. I noticed the front zipper of Parton's pants was completely unzipped, his pants were unbuttoned, and the only thing holding his pants on his body was his belt. I also noted a large amount of wetness around his crotch area and Parton generally smelled of alcohol and urine.

Parton advised he was coming from a gas station and headed back to a hotel. Parton stated he is in town for business. When I asked him to clarify where exactly he was coming from, Parton advised he was coming from a restaurant but denied having anything to drink despite the overwhelming odor of alcohol coming from his person.

I requested Parton perform Standardized Field Sobriety Tasks (SFSTs) and Parton immediately refused. I advised Parton that his failure to perform SFSTs would force me to make an arrest decision on the evidence I had thus far and his refusal could be used as evidence against him in court (Taylor Warnings). Parton advised he understood. I then provided a brief breakdown of each of the five SFSTs I would ask Parton to complete, should he be willing (Horizontal Gaze Nystagmus, Walk and Turn, One Leg Stand, Finger to Nose, and Romberg Alphabet). I also advised Parton that I would be willing, with his permission, to relocate to a more suitable place to conduct SFSTs, as I wanted to provide him the best possible opportunity to perform well on the tasks. Parton refused to participate in SFSTs.

Based on the evidence I had thus far, I placed Parton under arrest for DUI. I requested at roadside Parton provide a lawful sample of his breath for the purpose of determining the alcohol content. Parton refused. I read Parton Implied Consent from a prepared text, confirmed his understanding, and again requested he provide a breath sample. Parton refused at 0239 hours.

Based on the aforementioned facts resulting from my investigation, I find Probable Cause exists to charge Daniel Parton with DUI - Normal Faculties Impaired pursuant to FSS 316.193(1)(a).

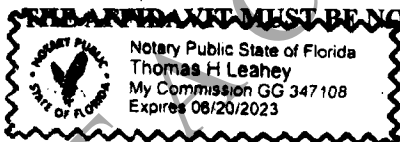
