Probable Cause

On Friday, September 1st, 2023, at approximately 2236 hours, I responded to Atlantic Park Towers, 1900 Dade Ave Boca Raton, FL 33431. This address is within the jurisdictional limits of Florida Atlantic University, Boca Raton Campus, 777 Glades Road, Boca Raton, Florida 33431, Palm Beach County. The information I received via my police radio referenced a women being walked around by a W/M who was mouthing to people that passed her to call the police.

Upon arrival, I made contact with a W/M in a white shirt later identified as Daniel Jon Roberts, DOB 03/08/2004, by his NH Driver's License, NHDL#NHL11101909. Roberts refused to answer any of our questions or to identify himself to us after multiple requests. I made contact with two B/F who were also present with Roberts later identified by their FLDLs as Gabrielle Fairweather, DOB 07/20/2005, FLDL#F636281057600 and Jada West, DOB 07/09/2005, FLDL#W230433057490.

Fairweather and West both stated that they had encountered Robert's on the first floor of Atlantic Park Towers, they stated that Roberts had ridden in the elevator with them up to the 7th floor where he began knocking on multiple doors and told them that he was trying to cause a disturbance.

At this time, I returned to Robert's who had been placed in handcuffs by Officer Torres and informed him that due to his refusal to answer questions and his issues remembering the questions that had been asked to him Boca Fire Rescue would respond to the scene to confirm that he was healthy. Boca Fire Rescue Truck 5, Run #2023-013133, responded to the scene and after a few moments confirmed that Robert's was not experiencing any medical emergencies, Boca Fire Rescue also stated that Robert's had told them he was a Type 3 diabetic, when asked whether he was a type-1 or type-2 diabetic. I informed Robert's that due to his belligerent and disorderly behavior he was under arrest and that he was intoxicated and endangered the safety of another person or property, or was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance, contrary to Florida Statute 856.011(1).

Roberts was placed in handcuffs, double-locked, and checked for tightness. I conducted a search of Roberts for weapons and contraband, which an Arizona Identification card belonging to a Joshua

Nathan Harris, DOB 04/21/2001 Arizona DL#D00613613. Robert's was unable to explain how he had come into possession of this identification card and refused to answer any questions regarding it. I informed Roberts that he did intentionally or knowingly possess, without authorization, the personal identification information of four or fewer persons in any form, including, but not limited to, mail, physical documents, identification cards, or information stored in digital form, contrary to Florida Statute § 817.5685(2) and (3)(a).

I placed Roberts in my marked patrol unit #1247 and transported him to PBSO Jail without incident.

The Harris' Arizona Driver's License was placed into evidence.


