The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, the affiant responded near the intersection of S Gornto Lake Rd. at Cardera Dr. in reference to an alleged impaired driver. Deputy A. Castle (ABN 263932) conducted a traffic stop on a dark grey BMW sedan bearing Florida tag 89JYA (VIN WBAGV8C06PCL64133) for driving on the wrong side of the roadway (east in the westbound lanes of Bloomingdale Ave.) and after observing its driving pattern. Deputy A. Castle observed the defendant to be the sole occupant and the driver of the listed vehicle. Upon Deputy A. Castle's contact with the defendant, he detected multiple indicators of impairment. During the affiant's contact with the defendant, he also detected multiple indicators of impairment, which included the odor of an alcoholic beverage emitting from the defendant's breath as he spoke, slurred speech and bloodshot, watery and glassy eyes. The affiant asked the defendant to do the Standardized Field Sobriety Exercises (SFSE's), which the defendant refused to do. The defendant was subsequently placed under arrest for DUI based on the totality of the circumstances. The defendant was transported to Central Breath Testing (CBT) where the affiant asked, but the defendant refused to provide the two lawful breath samples to determine his breath alcohol content (BrAC). The affiant read the defendant the Implied Consent warning, which he acknowledged understanding, but maintained his refusal to provide the two lawful breath samples. The affiant issued the defendant a DUI citation (AIUU7VE), which reflects the DUI charge. The defendant was identified via his Florida driver license.
