The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant caused a crash when she rear-ended the victim's vehicle, causing about \$30,000 in property damages and minor personal injury, then fled the scene of the crash without exchanging information. The defendant was driving her 2016 Chevy pick-up truck, bearing FL tag #94BQIF. The victim positively identified the defendant as the driver at the time of the crash via a "show-up". Upon making contact with the defendant, she displayed multiple signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on her breath, slurred speech, swaying as she stood, unsteady on her feet, and an admission to consuming alcoholic beverages. The defendant performed poorly on the SFSEs and was arrested for DUI with property damage and leaving the scene of a crash. The defendant later refused to submit to the breath test, despite acknowledging the Implied Consent Warning. The defendant has a prior refusal to submit to DUI testing on 03/07/2016 in Hillsborough County.

The defendant identified herself via her FL driver's license.
