The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving a blue 2021 Hyundai Sonata eastbound on W. Platt ST at a high rate of speed. I confirmed her speed via my Stalker DSR 800-E Radar to be 46 MPH in a posted 30 MPH speed zone. I then attempted a traffic stop, however the defendant was slow to react and continued to drive up onto the Selmon Crosstown Expressway for about 1 more mile before coming to a stop.

During the traffic stop, I identified her via a FL DL and noticed that she displayed several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, fumbling fingers, slurred speech, confusion, disorientation, she was dressed as a waitress with a Budweiser shirt (today was the Superbowl), she was also wearing a tan paper nightclub wristband on her right wrist, she admitted to drinking "1 Corona about an hour ago", and she emitted a distinct odor of an alcoholic beverage from her breath as she spoke.

The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking.

She agreed to take a breath test and willingly provided two valid samples, measuring .137/.139 BrAC.
