On 4/12/2024 at approximately 1513 hours, I arrived at [REDACTED] to investigate a domestic dispute complaint. I spoke with Mr. Yared Alemayehu, who told me the following in a sworn recorded statement.

Early that morning at approximately 0900 hours, he arrived back to his apartment after dropping off his girlfriend's child at school and going to the gym. As he began to start the shower he was approached by his girlfriend, Dannielle Swart, who seemed to be agitated. She questioned him as to why he was taking a shower and that she needed to use the shower to get ready for work. He then shut off the shower and left the bathroom to go to the second bathroom and shower there. He locked the door behind him only to find that she used something to defeat the lock and attempted to open the door to continue the argument. He said he pushed the door closed and secured the door once again only to have her continue this same behavior over and over. During these incidents she also reached around the door and attempted to hit, scratch and bite him. He was finally able to secure the door and begin taking his shower when she burst in the final time as he was drying off and she was armed with a taser this time. He claimed to have disarmed her and she then began punching, kneeling and biting him again. He did sustain obvious injuries to his person during this interaction. I observed large scratches, bruises and what was said to be a bite mark on his arms and thumb. He also claims to have been kned in the rib cage and groin which caused him to vomit in the toilet and seek medical attention. He then gathered up his belongings and left the residence only to decide later to make a report after speaking with several people.

I then spoke with Ms. Swart at her apartment and she did agree to voluntarily speak with me about her version of this mornings events.

She claimed that it was Alemayehu who face washed her during their argument and that she fell to the ground injuring her knee. She claims it was Alemayehu who grabbed her laptop and phone locking in inside the bathroom with him and thats why she was trying to get in. She had no visible injuries.

Based off the statements given by Mr. Alemayehu along with the physical injuries consistent with those allegations, probable cause does exist to arrest and charge Ms. Dannielle Swart for Domestic Battery in viloation of FSS 784.03 1A1, as the two are involved in an ongoing romantic relationship and do reside with one another as if a family.
