VICTIM INFORMATION CONFIDENTIAL PER MARSY'S LAW

On January 13, 2024 at approximately 11:58 PM, officers were dispatched to [redacted] in reference to a 911 hang up. Upon arrival on scene, officers utilized their body worn cameras and made contact with a white male identified as Josef W. Chowaniec (D.O.B. 02/26/1958) and his wife of approximately forty (40) years, a white female identified as Danuta A. Chowaniec (D.O.B. 06/16/1959).

Josef began speaking with officers and advised that he and Danuta were having an argument that spilled over from a disagreement they had earlier at their church. During the course of the argument, Danuta became upset and called the police, but immediately hung up the phone without speaking to a dispatcher.

Officer Topping spoke with Danuta, who confirmed that an argument took place, but stated that the argument never became physical. Officer Topping asked Danuta how Josef acquired the injury to his arm, but she replied that she was unsure and explained that Josef is prone to injury due to his medical condition.



out of frustration as he was walking away, but did not mean to cause any injury to him. Officer Topping photographed and later uploaded Josef's injuries into evidence.

Due to the above described investigation, Danuta A. Chowaniec (D.O.B. 06/16/1959) was placed under arrest and charged with one (1) count of Simple Battery (Domestic). Danuta complained of feeling ill and was transported to St. Mary's Medical Center for clearance. Danuta was later processed and transported to the Palm Beach County Jail for booking purposes. Josef was provided with a Victim's Rights Pamphlet containing an R.B.P.D. case number.
