On 02-10-17 I met with _____ at the Palm Beach Gardens Police Department. _____ briefed me on the above information. _____ informed me that on 02-07-17 (after she reported the incident before Abner knew _____ was aware) Abner picked the girls up from school without permission. He picked up the girls at 2pm and did not notify her until 2:30 pm that he had them. _____ panicked and told him to bring the girls home right away. Abner was not aware of the criminal investigation. _____ advised she spoke with the girls after Abner dropped them off and they were terrified that Abner picked them up. _____ stated she didn't feel well so that Abner would take her home right away. Abner insisted he take the girls for ice cream and to a toy store. He took them for ice cream and then after speaking with _____ he brought the girls home. _____ told her mother that Abner asked them "Does mom know anything" as he looked down towards his penis and _____ said, "No." It should be noted _____ informed me that _____ has been diagnosed on the spectrum for

Autism by her school psychologist. █████ agreed to make a one-party consent call to Abner on his cell phone. Abner did not answer his phone and the two exchanged a brief text. On 02-11-17 Abner called █████ and she did not answer. Abner texted her asking if they could talk and █████ agreed to call him at 3pm. █████ notified me and I met her at the police department so the call could be recorded. Abner and █████ did speak via their cellphones and they talked for a total of 3 calls which were recorded. Abner at first admitted the girls might have saw his pubic area but he didn't think they saw his penis. Abner advised he was dancing and his pants fell. █████ advised both girls gave an account of what happened and she talked with them separate and they both advised that he unzipped his pants. Abner advised that was not what happened. █████ asked if the girls were liars and Abner advised they are not liars. Abner eventually admitted that the girls may have seen his penis but he advised it was only because he was dancing. Abner stated he had his hands on his hips and the girls could have mistaken that for being on his zipper. Abner admitted he told the girls not tell █████. Abner apologized and asked for █████ not to involve the police. During the recorded statements Abner did not appear to be truthful. Due to the allegations, a forensic interview was arranged for █████ and █████ on 02-13-17 by Senior Case Coordinator (SCC) Katherine Stangeland of the Child Protection Team and they were taken to the interview by their mother, █████. SCC Stangeland met with █████ and █████ individually. █████ advised that on 02-02-17 Abner unzipped his pants exposed his penis. █████ advised that Abner had exposed himself to her in the past by opening his towel and told █████ not to tell her mom or he would say she was lying. █████ stated when she was younger Abner asked both her and █████ at the same time if they wanted to touch his penis and both girls answered, "No." █████ also disclosed on a Saturday in Dec 2016 during her winter break Abner laid behind her on the couch and cupped her breast with his hand and poked it (█████ demonstrated the act). This occurred over her clothing. █████ advised in the early morning hours Abner came into her room and woke her up. █████ advised she woke up █████ and they went into the living room and █████ was watching a music video. █████ advised Abner unbuttoned his pants, pulled down his zipper and took out his penis. █████ advised and demonstrated that Abner started moving his penis up and down. █████ advised that Abner asked them "Does mom know anything" as he looked down towards his penis and █████ said, "No." I observed the interviews from a separate room via a recorded closed circuit television. I also obtained a copy of the interviews and placed them into evidence.
