On 07/04/2017 at 0300 hours, while conducting routine patrol in the area of 200 N. Dixie Hwy, I observed a silver 2007 Pontiac G5 bearing FL tag M596LS traveling westbound in the intersection of Dixie Hwy and NW 2nd St, which had a solid red light. I was traveling northbound on N. Dixie Hwy. when I observed the vehicle slam on his brakes and come to a complete stop blocking the pedestrian crosswalk. I then made a right turn on NW 2nd St and observed the Pontiac run the red light and start traveling southbound on NW 2nd St.			
I conducted a traffic stop at 200 W. Palmetto Park Rd, where I made contact with the sole occupant and driver of the vehicle, who later identified himself by his FL DL as Adam Banyas. Upon speaking with Banyas, I observed his eyes were red/bloodshot. I was able to smell an odor of an alcoholic beverage emitting from his breath. I asked Banyas why did he ran the red light and he stated he did not noticed the light was red. I asked Banyas if he had anything to drink tonight and he stated no. Banyas advised he had just left his girlfriend's house and that she was coming to pick him up and his vehicle. He was also fumbling around looking for his documents.			
I then asked Banyas to step out of his vehicle, which he did. As he was stepping out of the car, he was swaying side to side, he used his driver side door for balance. As I was speaking with him outside of his vehicle, I still detect a strong odor of alcohol emitting from his breath. I explained my observation to Banyas and then asked that he performed the standard roadside exercise to dispel my alarm he was driving impaired. Banyas refused. I then informed him that if he refused I will be forced to make a decision based on my observations. Banyas stated he understood and refused again.			
At 0312 hours, I placed Adam Banyas under arrest for driving under the influence per F.S.S. 316.193(1). He was transported to BRPD for processing. Officer VanCamp
