On April 16, 2017 at approximately 1521 hours I was dispatched to a domestic battery investigation located at 8775 Rheims Road, in unincorporated Boca Raton FL 33496. The victim in this case W/F Susan Bruner called 911 and stated that her son Adam Bruner is being violent. She stated that her son battered her hand and then she slapped him. She also stated that Adam may have a gun on him. She also stated that Adam stated to her here's my gun go kill yourself.

As I approached the house I can hear a male voice yelling. I knocked on the door and identified myself and Deputy Udehl as the Sheriff's office. Susan Bruner came outside the front door and I told her to wait down the street. The door was now open and I made numerous announcements for Adam to come out of the residence and also stating we were the Sheriff's Office. Let be noted that I and Deputy Udehl were wearing class B uniforms, with badges and patches identifying us as the Palm Beach County Sheriff's office. Sergeant Phillips spoke with the victim down the street and she stated to him her son Adam was yelling inside of the residence. Adam got in her face and was yelling in her face. Susan struck Adam in a defensive manner to get away from Adam's aggressive behavior towards her. He then struck her back. Susan also mentioned Adam stated he would give her his gun, so she can commit suicide. Susan is in fear of her son's behavior. After numerous announcements Adam Bruner came out of the residence. He was yelling at us and he was given commands to get on the ground. Once he was on his stomach on the ground deputies approached and I placed him and handcuffs, checked for tightness and proper fitting.

After Bruner was in PBO custody, he was brought to the rear of my vehicle to be checked once more before being placed into the rear seat of my vehicle. After I completed my check of Bruner and examined his handcuffs for proper fit, I and D/S Udehl requested Bruner to enter the rear of my vehicle. Bruner did not comply with our request and he became belligerent and he physically resisted our efforts to get him into the police car. While attempting to get Bruner in the back of my vehicle, Bruner kicked D/S Udehl in the front of his left leg with his left leg. Bruner was standing directly in front of D/S Udehl when he did a rear kick to D/S Udehl's leg. After D/S Udehl was kicked by Bruner, I and D/S Udehl were able to gain control of Bruner and we assisted him into the rear of my patrol vehicle.

Brunner was taken out of my vehicle again due to him complaining of the handcuffs. I rechecked the handcuffs and appeared and they fit properly. While Bruner was outside the vehicle I and D/S Udehl told Bruner to get back inside the patrol car in which time he did not comply with our lawful order. I then assisted him into the patrol car.

On 4/16/17 at approximately 1525 hours I responded to 8775 Rheims Rd. in unincorporated Boca Raton in reference to a domestic battery complaint in progress. Upon arrival, the victim/complainant exited the residence while the suspect, Adam Bruner, was still inside. Numerous verbal commands were given to Bruner to exit the house. At approximately 1545 hours, Bruner exited the house and he was taken into custody.

After Bruner was in PBSO custody, he was brought to the rear of D/S Calloway's vehicle to be checked once more before being placed into the rear seat of D/S Calloway's vehicle. After D/S Calloway completed his check of Bruner and examined his handcuffs for proper fit, D/S Calloway and I requested Bruner to enter the rear of D/S Calloway's vehicle. Bruner did not comply with our request and he became belligerent and he physically resisted our efforts to get him into the police car. While attempting to get Bruner in the back of D/S Calloway's vehicle, Bruner kicked me in the front of my left leg with his left leg. Bruner was standing directly in front of me when he did a rear kick to my leg. After I was kicked by Bruner, D/S Calloway and I were able to gain control of Bruner and we assisted him into the rear of D/S Calloway's Vehicle.

As a result of Bruner's actions against me, it was evident that Bruner did actually and intentionally strike me D/S Udell, a PBSO Deputy in full uniform, while engaged in the lawful performance of duty and while Bruner knew that I was a law enforcement officer commit the crime of battery on a law enforcement officer contrary to Florida State Statute 784.03(1).
