On the 22 day of April, 2018 at 02:39 (Specifically include facts constituting cause for arrest.)

On 4-22-2018 at 0221 hours, while on routine patrol I observed a White BMW vehicle bearing Fl Tag#MDY4942 traveling southbound on N. Federal Hwy at a high rate of speed. I visually estimated the vehicle to be traveling 60 mph in a 35 mph zone. I pulled out into the southbound lanes of travel and began following the car. The vehicle traveled west onto NE 8th St. and then southbound on N. Dixie Hwy at a high rate of speed. The vehicle came to a solid red-light at the intersection of N. Dixie Hwy and E. Palmetto Pk Rd. The vehicle proceeded to conduct a U-Turn against the solid red-light. At this point, I conducted a traffic stop on the car. I made contact with the driver, Adil Khan, and the passenger W/F Cindy Baumal-Muchnick. Upon making contact with Khan, I detected the strong odor of alcohol coming from his person and his eyes were bloodshot. Khan also had a slowed reaction time while speaking with me. I asked Khan why he ran the redlight and he stated that "no one was coming." Ofc. Coon arrived on scene a short time later.

I requested that Khan exit his vehicle so that I could ask him further questions. Khan exited without incident and walked to the front of my marked police vehicle along a solid line. I informed Khan that I could smell alcohol coming from his person but Khan advised that he does not drink alcohol because he is a Muslim. I asked Khan if he knew where he was and stated he was somewhere "south of Delray Beach." Khan also did not know what roadway he was on. Khan advised that he is traveling to his friend's house after a night out in Delray Beach, Fl.

After speaking with him I asked if he would consent to the standard roadside exercises to dispel my alarm that he was driving impaired, he provided consent. I explained and demonstrated each task.

Khan stated he does not take medications and has no serious injuries that would prevent him from completing the tasks.

The first task was the Horizontal Gaze Nystagmus. While observing HGN, each eye had a constant jerking while at maximum deviation. Lack of smooth pursuit was present in both eyes. The second task was the Walk and Turn. Khan started the exercise early twice. He only took 8 steps forward. He did not maintain the starting position the entire time as instructed. He momentarily fell off the line upon returning after the first 8 steps. The third task was the One Leg Stand. Khan started the exercise early. He used his arms to maintain his balance. He did not look down at his feet the entire time as instructed. Khan stopped at 1017 and wasn't sure what to do. I informed him to complete the task until told to stop. The fourth task was the Finger to Nose exercise. Khan held his finger to his nose on the first finger to sequence. The fifth task was the Rhomberg Alphabet. Khan completed this task without incident. At 0239 hours, I placed Khan under arrest for DUI per F.S.S. 316.193(1) and transported him to the booking facility. I conducted the 20 minute observation period. While in the DUI room, Khan provided the breath samples of .125% and .127%. Khan was later transported to the Palm Beach County Jail without incident. The vehicle was towed to Westway Towing.
