When I was behind the white BMW, my vehicle's speedometer read approximately 96 miles per hour. I drove behind the vehicle for approximately a quarter mile. After reading off the information needed to conduct a traffic stop, the white BMW slowed down and turned east at Hypoluxo Rd and State Road 7. Once turned onto Hypoluxo Rd, I activated my blue and red over head emergency lights. The vehicle came to a stop in a right turn lane. Once at a complete stop, I exited my vehicle and approached the white BMW. Upon approaching the white BMW, I observed a smaller framed female in a black top and a white dress. When asked for her license, she reached for her larger wallet, and opened the wallet. At first, the female was holding the wallet up to her to see the contents of her wallet, but then appeared to loose strength in her arms and dropped her arms and the wallet onto the steering wheel for support. The white female continued to search though her wallet, passing her FL drivers license once. She then attempted to hand me her wallet but then took her wallet back to rest her wallet on the steering wheel. On the second attempt of finding her FL drivers license, she found her license within her wallet. After handing me her FL drivers license, She slumped over her middle counsel of the BMW and opened the glove compartment of her vehicle. DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07Apr17 at approximately 2345hrs I arrived in the area of 9650 Hypoluxo Rd, Boynton Beach, in unincorporated Palm Beach County in reference to a Driving Under the Influence (DUI) investigation.

Upon arrival I spoke to D/S M. Collura (26708). He told me at approximately 1125Hrs, he observed a White two door BMW (FL plate 025QUH) "straddling the white line of the far right lane and the roads shoulder". The white BMW was traveling approximately 60 mph while I observed the vehicle. While passing the vehicle from the far left, the vehicle veered off further past the white lane of the far right lane. He then slowed his vehicle down and drove just behind the vehicle. He observed the white BMW accelerate to a high rate of speed. He paced the vehicle at 96mph in a 45mph zone (VIN 2FAHP71W46X142121) for approximately a quarter mile. The white BMW slowed down and turned east at Hypoluxo Rd and State Road 7. He then conducted a traffic stop on the vehicle on Hypoluxo Rd.

D/S C. Engel (9576) was traveling in her marked patrol vehicle next to D/S Collura. She observed the same driving pattern and acted as the backup officer for the traffic stop.

OBSERVATION OF DRIVER:

Upon approaching the white BMW, D/S Collura and D/S Engel observed a "smaller framed female in a black top and a white dress" in the driver seat. When he asked for her license, she reached for her larger wallet, and opened the wallet. At first, the female was holding the wallet up to her to see the contents of her wallet, but then appeared to loose strength in her arms and dropped her arms and the wallet onto the steering wheel for support. The white female continued to search though her wallet, passing her FL driver's license once. She then attempted to hand D/S Collura her wallet but then took her wallet back to rest her wallet on the steering wheel. On the second attempt of finding her FL driver's license, she found her license within her wallet. After handing him her FL driver's license, she slumped over her middle counsel of the BMW and opened the glove compartment of her vehicle. The registration and insurance information were found without trouble. He identified the female by her Florida driver's license as ADRIANA ALMA SAENZ.

After I arrived on scene I approach the driver's side of the vehicle. I observed Adriana sitting in the driver's seat of the BMW. I could smell a perfume smell and a light smell of an unknown alcoholic beverage coming from inside the vehicle. Her eyes were watery and her speech was slow. I handed her registration and insurance back to her. She fumbled through the glovebox then through the floorboard on the driver's side. She eventually located the owner's manual binder. She had difficulty placing the papers back in the binder.

DRIVER'S STATEMENTS:

While talking to Adriana, D/S Collura asked what she had been doing before he pulled her over. Adriana Stated she was on her way back from Boca, and was at a friend's house. Her friend just got out of surgery and was having a small get together. When he asked if she had been drinking at the party, Adriana stated "not really, yes". While talking to Adriana, D/S Collura could smell a sweet odor of an alcoholic beverage. He told me her eyes seemed to be glassy with a very little tint of red. I did not observe any alcoholic beverages within the vehicle.

ODORS:

Perfume and an unknown alcoholic beverage coming from inside the vehicle and from her person.

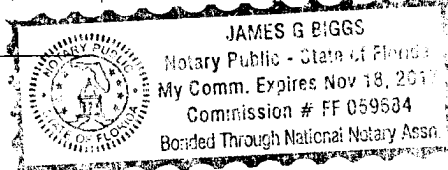

Other Observations:

Her body sway during the task. Her eyes were watery. I had to remind her several times to follow with her eyes only. She had Vertical Gaze Nystagmus (VGN) but did not have Lack Of Convergence (LOC)

WALK & TURN:

I instructed and demonstrated the Walk and Turn. She acknowledged she understood. She did not stand as instructed and had to step off the line. She took 9 slow steps forward. She stepped off the line several times. She took 9 steps back missing heel to toe on several steps. The task was completed on a dry and level surface using a wide white painted line on the roadway wearing no shoes.

ONE LEG STAND:

I instructed and demonstrated the one leg stand. She acknowledged she understood. She lifted her left leg. Her right leg wobbled during the task. She held her arms tightly against her sides during the task. Her body swayed. The task was completed on a dry and level surface wearing no shoes.

FINGER TO NOSE:

I instructed and demonstrated the finger to nose. She acknowledged she understood. During the task her body swayed. Her eyes were partially opened during the entire task. The first set of commands she touched underneath and side her nose. On the final commands she touched her nose with the pad of her finger. Her eyes were partially open during the entire task. The task was completed on a dry and level surface.

ROMBERG ALPHABET:

I instructed and demonstrated the Rhomberg alphabet. She stated she had not graduated high school but did know the English alphabet "perfectly". She attempted the alphabet. She skipped several letters and repeated others. When she finally got to the letter "y" she stated she didn't know the alphabet. I had her repeat the task by counting. She counted slowly. She had her eyes open partially during the entire task and her body swayed. The task was completed on a dry and level surface.

I instructed the Modified Rhomberg. She acknowledged she understood. Her estimate of 30 seconds was approximately 1 minute. During the task she counted very slowly. She had her eyes open partially during the entire task and her body swayed. The task was completed on a dry and level surface.

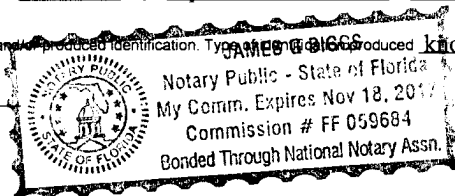

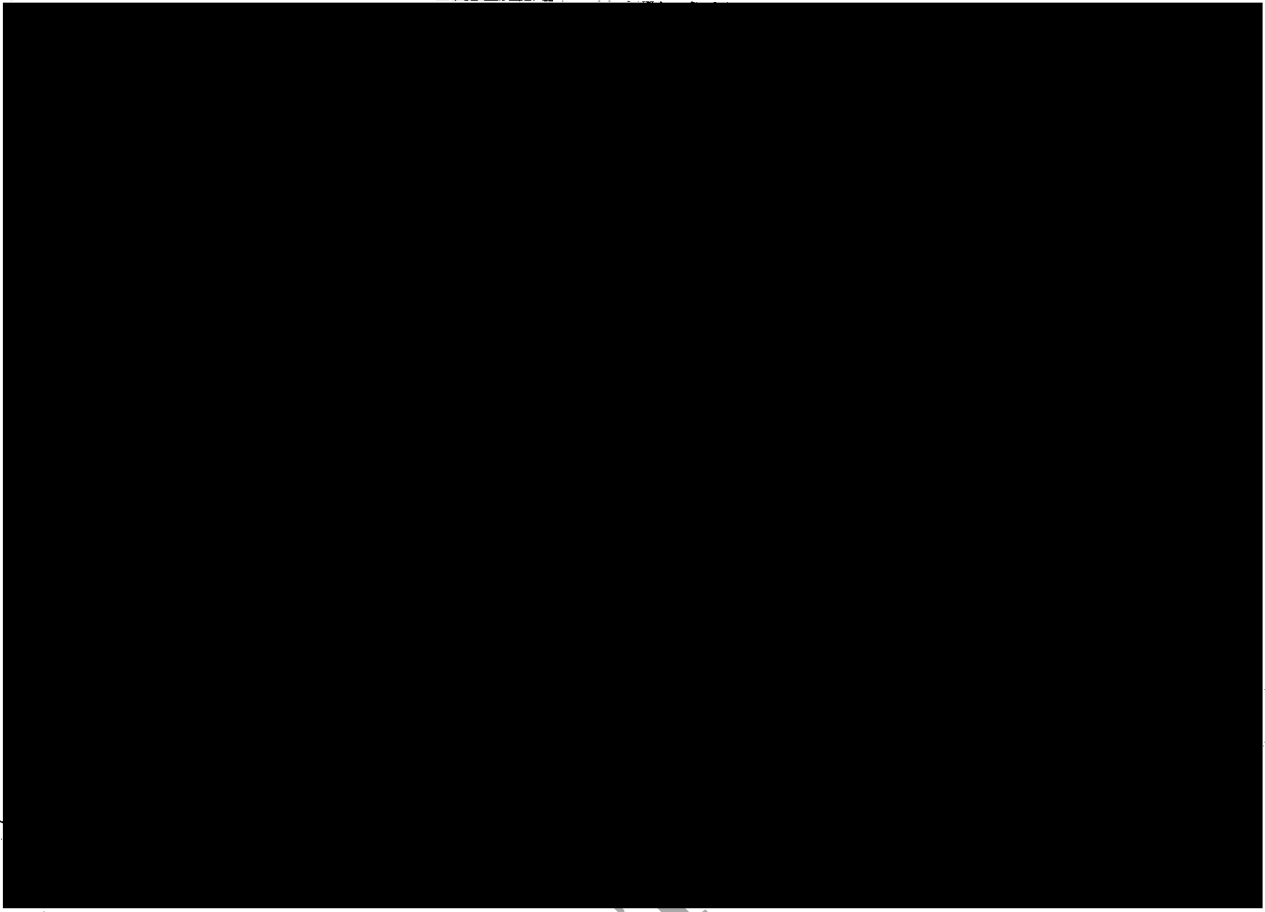
