Narrative:

I responded to the BBPD lobby located at 100 E Boynton Beach Boulevard, Boynton Beach, FL in reference a delayed battery. The victim, W/M Eric Rosberg (DOB 05-19-1978), came into the lobby to report that his girlfriend of five weeks, W/F Adrienne Kurman (DOB 04-01-1977), had battered him.

Upon my arrival, I made contact with Eric, who provided me with a sworn statement which was captured through my body worn camera. According to Eric, he was at Adrienne's apartment for a gathering, which is located at 3327 S Federal Highway - Apt. C, Boynton Beach, FL. While there, Eric left his cell phone unattended, at which time he received a text message from another female he is having an affair with. According to Eric, Adrienne saw the message and became extremely upset with him. Eric stated that after the guests left, Adrienne confronted him and began battering him. When asked how he was battered, Eric stated that Adrienne delivered multiple closed fist and elbow blows to the back of his head as he was trying to cover up and defend himself. While being attacked, Eric stated he pushed Adrienne away in an attempt to gain distance. Eric was eventually able to break free from Adrienne and walked away. Shortly after, Eric added that him and Adrienne still sat down and had a short conversation, however, Adrienne yelled at him to leave her residence. Eric then complied with Adrienne's orders and went home. While at his residence, Eric stated he was persuaded by a room mate to report the incident to authorities, at which time he came into the police station personally. Eric had multiple knots to the back of his head, as well as scratch marks on his neck area and swelling and bruising to his right eyelid. Eric stated that all marks and injuries resulted from being attacked by Adrienne. Eric stated the incident took place on the hallway and kitchen area and that both him and Adrienne were standing up at all times. Medical treatment was offered and refused by Eric.

After concluding obtaining a statement from Eric, I then responded to Adrienne's residence (327 S Federal Highway - Apt. C), to attempt to make contact with her. There, I made contact with Adrienne, who provided me with a sworn statement which was captured through my body worn camera. Adrienne corroborated Eric's account of how the incident initiated and added that the guests left because they were uncomfortable being there after she read the messages on Eric's phone. According to Adrienne, after the guests left her apartment, she went to the bathroom and locked herself inside, at which time Eric followed her and begged for her to open the door. At one point, Adrienne stated she opened the door, at which time Eric began yelling at her and pushed her with both hands on both her shoulders. After being pushed, Adrienne stated she pushed Eric back and began punching him. Adrienne stated she punched Eric repeatedly with closed fists to the back of his head. Adrienne stated she was pushed against the bathroom wall twice during the struggle. Adrienne was unable to provide specific details or a timeline of how the incident took place and stated that somehow she was on the ground on her back, with Eric on top of her. While on the bottom, that's when Adrienne stated she punched Eric on the back of his head. It should be noted that Adrienne's story was inconsistent as it is nearly impossible for someone laying down on the ground to generate enough power and create the extent of damage present on the back of Eric's head. Adrienne had a slight red mark to her center chest area, however, it is inconsistent with her being pushed as she stated that she was pushed on both shoulders. Adrienne was also observed rubbing on her chest multiple times on scene. There were no injuries or marks on Adrienne's back to corroborate her being pushed against the wall. Adrienne had small scratches and redness to both her knuckles, consistent with her delivering closed fist blows. Medical treatment was offered and refused by Adrienne.

Based on the above facts and circumstances, at this time I find probable cause to charge Adrienne with one count of misdemeanor Simple Battery, pursuant to FSS 784.03(1A1). Even though Eric admitted to pushing Adrienne, he did so while acting in self-defense. A FCIC/NCIC/PALMS check for active warrants was conducted on both Eric and Adrienne, yielding negative results. Adrienne was transported to BBPD headquarters for processing and ultimately TOT PBCJ without incident. Nothing further at this time.

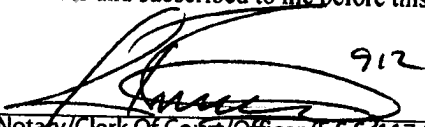
