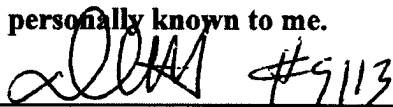

On Monday, September 9, 2019, at 1915 hours, I arrested and charged, Adrienne L. Crow (W/F DOB 7/15/1999) with Filing a False Police Report to a Law Enforcement Officer Pursuant to F.S.S. 837.05. The details are as follows:

On Friday, September 6, 2019 at approximately 1829 hours, Town of Palm Beach Police Officers responded to the Meat Market located at 191 Bradley Pl for a suspicious incident. Upon arrival, PBPd Officer Y. Agaoglu met with employee and victim, Adrienne Le Crow (W/F DOB 7/15/1999). Crow stated that at approximately 1810 hours, she was walking alone to her Red Nissan bearing FL tag CZET26, which was parked at the parking lot behind Chase Bank located at 285 Sunrise Ave, Palm Beach, FL. Crow stated she observed an older dark blue Ford F150 truck, with a ladder and ropes in the bed of the truck, traveling southbound on Bradley Place.

Crow stated that as she walked toward her vehicle, the truck pulled up next to her, parallel to the parking lot entrance on Bradley Place. An unknown male got out of the truck and grabbed both her arms from behind and tried pulling her closer to him. She described the male as in his 50's, 5'10, short brown hair, salt & pepper colored short facial hair, blue plaid shirt, wearing jeans, a brown belt and tan work boots. She stated she slowly turned around as she thought it was one of her coworkers. She stated that she did not recognize him and was able to pull up her phone as if she were to call someone. Crow stated that's when the unknown male let her loose and said "I'm going to find you one way or another". Crow stated that the unknown male got back into the truck, made a U-turn and left the scene traveling northbound on Bradley Place. Crow stated that the first letter of the license plate was possibly "Y".

Crow then walked over to her vehicle and sat in it for a few minutes until she walked back to the Meat Market and notified her manager, Mathis Cooper, who contacted PBPB.

An area canvass of the suspect/vehicle was conducted by multiple officers with negative results.

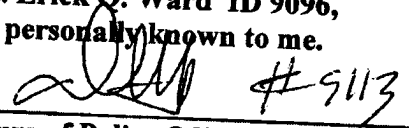
Shortly after, PBPB Officers transported Crow to the Palm Beach Police Department where I conducted a taped interview. Crow's statement was consistent with the verbal and sworn written statement that she had provided earlier to PBPB Officer Y. Agaoglu.

On Monday September 9, 2019, I responded to The Palm Beach Biltmore Condo, located at 150 Bradley PL, Palm Beach, FL. The Biltmore Condo is located directly across the street from where Crow alleges that the incident occurred. The Biltmore Condo had a camera positioned toward the parking lot of the alleged incident. Upon reviewing the cameras, at 1817 hours, Crow is seen walking southbound along the sidewalk on Bradley PL and then she enters the parking lot where the alleged incident occurred. Crow continues walking until she arrives at her red Nissan and enters the vehicle via the driver side door. A short time later, Crow exits her vehicle and walks around the back and then onto the right passenger side. Next, Crow is seen walking northbound in the parking lot and then eventually goes out of the view of the camera. I reviewed the camera footage several different times, and never observed a blue Ford F-150 or any vehicle travel into the parking lot where Crow alleges that the incident occurred. Furthermore, after reviewing the video, I did not observe any other individuals other than Crow in the parking lot during the time that Crow alleges the incident occurred.

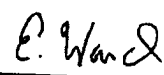
On Monday, September 9, 2019, Crow responded to the Palm Beach Police Department for a follow-up interview. In a recorded statement, Crow re-confirmed her aforementioned sworn statement. I advised Crow of her Miranda Rights using a preprinted Miranda Card. Crow signed the Miranda Card acknowledging that she understood her rights. Post Miranda, Crow admitted that she had fabricated the entire incident to gain, "Attention". Crow stated that she knew that it was wrong and she felt embarrassed.

Based on the facts in this case, I find probable cause exists to charge Adrienne Le Crow (W/F DOB 7/15/1999) with Filing a False Police Report pursuant to F.S.S. 837.05. At 1915 hours, Crow was placed into handcuffs which were checked for tightness and double locked. Crow was transported to the Palm Beach County Jail without further incident.
