On 10-05-18 at approximately 0138 hours, I was dispatched to 1209 Town Center Dr. Apt# 212, Jupiter, FL 33458, in reference to a welfare check called into 911 by Aerial Jones (W/F 1-28-97), advising that her boyfriend Cody Jorgenson (W/M 2-5-97) had taken multiple unknown pills and she then advised over the phone that she found them in the trash can. Northcom advised that they could hear shouting in gthe background and what appeared to be a struggle. Upon my arrival, I observed shouting from a male and female voice coming from within the apartment. I knocked on the door and was told by the female voice to come in. As I opened the door, Jorgenson came outside and began saying take me to jail and he laid down on his stomach and placed his arms behind his back without any such commands being given by myself or backup Officer Morgan. Jorgenson and Jones both smelled of an unknown alcoholic beverage and appeared to be intoxicated. Jones and Jorgenson reside together, have been dating for six months, and Jones is pregnant with his child.

I spoke with Jones inside the apartment and she stated the following: Her and Jorgenson were at Jumby Bay (1203 Town Center Dr.) drinking, when they began arguing over petty issues. He left to go back to their apartment and then came back down a short time later with her dog and gave it to a stranger to hold. He then yelled into Jumby Bay to tell her that someone has her dog so he could get her attention. They began arguing again and Jorgenson was asked to leave by employees of Jumby Bay. She then advised that she went back to the apartment with him where he told her that he took a lot of ibuprofen and she became worried and called 911. After she spoke with the dispatcher, she advised that he did not take an abundant amount of ibuprofen and found the loose pills in the trash can. Jones then stated that an altercation ensued but would not elaborate on what the altercation consisted of. I did observe slight red marks on Jones' left arm and upper chest and a scrape on her left knee. I photographed her injuries.

I spoke with Jorgenson in the hallway and he advised the following: After an argument at Jumby Bay, he left his girlfriend at the bar and went back to their apartment. He then came back to Jumby Bay after approximately 30 minutes, with Jones' dog. He stated that he gave the dog to a friend of his to hold outside the bar and called into his girlfriend that someone was holding her dog, because he thought that would be the only way to get her to come outside and talk to him. Jorgenson then stated that he and Jones began arguing again and she punched him in the face. He advised that there were multiple witnesses at Jumby Bay that saw what happened. I observed scratch marks on both sides of Jorgenson's neck, slight swelling and an abrasion on the left side of his face, and scratch marks on both of his wrists. Jorgenson became uncooperative and refused to provide a sworn statement. I photographed his injuries.

I then proceeded to go downstairs and speak with the staff at Jumby Bay and Christa Grimaldi (W/F 7-14-86) stated the following: She witnessed Aerial and Cody at the bar drinking around 2230 hours and noticed them to be getting along. Grimaldi advised that they frequent Jumby Bay often and are always arguing and shoving each other. She then stated that at approximately 0030 she observed Jones and Jorgenson outside in front of the Barber Shop located next to Jumby Bay, arguing and she witnesses Jones punch Jorgenson in the face multiple times. Gramaldi stated that she went over to them and intervened, which caused Jones to stop punching Jorgenson. She then advised that Jorgenson left the area but returned a short time later. Grimaldi advised that she spoke with both of them once again about not fighting and they both left together towards their apartment. Grimaldi provided a sworn statement.

Based upon my above described investigation, I determined that Aerial Jones was the primary aggressor in the domestic altercation and I found probable cause to arrest her for Simple Battery (Domestic), pursuant to 784.03(1) as she did actually and intentionally touch or strike Cody Jorgenson against his will.
