On 3/3/2019 I was dispatched to a reported vehicle collision in the area of the Interstate 95 northbound

on 3/3/2019 I was dispatched to a reported vehicle collision in the area of the Interstate 95 northbound exit ramp to 6th Avenue. Upon my arrival Fire Rescue was already on scene and had the three left lanes of the exit ramp blocked off. There was a light colored Nissan Altima (attached FL tag: 49367L) at a complete stop in the left lane with heavy damage to the front with the airbags deployed. Ahead there was a white Ford passenger van (attached FL tag: 908PKC) with damage to the rear consistent with a front to rear end collision with the Nissan Altima. The driver of the white Ford passenger van was transported to JFK Hospital. Deptuy M. Barbusio (#29006) observed Mr. Anilan behind the wheel of the As I spoke to the driver I smelled the strong odor of an alcoholic beverage coming from his breath as he spoke. He was also unsteady on his feet and his speech was very slurred. His eyes were noticeably red and glassy. After completion of my crash investigation I informed Mr. Anilan and let him know that I was beginning a criminal investigation for DUI. Mr. Anilan's daughter Burco Anilan traveled to the scene and translated from English to Turkish and Turkish to English although Mr. Anilan did speak and understand basic English well. I read him his Miranda Rights from a Florida Highway Patrol Miranda Warning printout. He stated that he understood his rights and was not willing to answer questions asking for a lawyer. I informed Mr. Anilan that based upon my observations I believed that he was under the influence and asked him to perform standardized field sobriety exercises and he stated that he was willing to perform them. He stated that he did not wear contacts but did occasionally use reading glasses. He stated that his natural eye color was brown which was observed. He also stated that he did suffer from ulcers but did not have any other medical conditions and was not hurt. The results of those exercises are summarized below. Each exercise was explained and demonstrated prior to the subject attempting to perform the exercise.

Horizontal Gaze Nystagmus Exercise

- -Moved entire head multiple times despite being instructed not to
- -Lack of smooth pursuit in both eyes
- -Exercise was terminated prior to completion due to subject being unable to follow instructions

Walk and Turn Exercise

- -Unable to stay in starting position
- -Started exercise prior to command to begin
- -Stepped off line on multiple occasions
- -Did not turn around correctly as instructed

One Leg Stand Exercise

- -Used arms to balance
- -Placed foot down multiple times

Based upon the performance of the above exercises and the totality of the circumstances I determined that there was probable cause to believe that Ahmet Anilan committed the offense of driving under the influence by being in actual physical control/operating a motor vehicle while under the influence of alcohol or any controlled substance per Chapter 893, while their normal faculties were impaired. He was placed under arrest for the above offense and handcuffed behind his back. After being searched he was placed in the backseat of my marked patrol vehicle. Both vehicles were towed from the scene by a rotational wrecker. Mr. Anilan was then transported to the Palm Beach County Breath Alcohol Testing (BAT) facility. At the BAT facility a 20 minute observation period was conducted where the driver did not ingest anything by mouth or regurgitate (mouth was confirmed to be empty prior to beginning of the observation period). He was then asked to provide a breath test sample to test for the alcoholic content of his breath. He initially stated that he was unwilling to give the breath test sample. I then read the Florida Implied Consent drivers license suspension warning and again asked him if he would provide a breath test sample. He agreed to provide the breath test samples and provided a first breath test sample of 0.165 and a second breath test sample of 0.173. He was subsequently booked at the Palm Beach County Jail without incident. Ahmet Anilan was issued a DUI citation for driving under
