I responded to E Ocean Ave and NE 4th St reference a disturbance. Upon arrival, I spoke to Jade Noel who stated her cousin Aimee Elizabeth Carland (Defendant) was attempting to drive her vehicle while intoxicated. Noel stated that Carland's children were also inside of the vehicle at the time. Noel stated that her mother Rosemary Noel and her were in possession of the vehicle keys and that Carland was upset that they would not give her the keys. Noel advised due to Carland's intoxication she had fallen in the parking lot on her face which caused a bump and abrasion to her right forehead area.

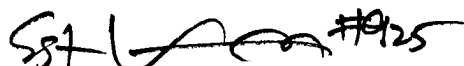
I spoke to Carland who was being treated by BBFD for the injury to her head. Carland refused any other further medical treatment from BBFD. While speaking with Carland I observed her to have blood shot glassy eyes, slurred speech and a strong odor of an unknown alcoholic beverage coming from her person. Carland then began to yell and stated "can I just smash those bitches" and began to yell louder and walk towards Noel and Rosemary. Due to Carland's aggressive actions, she was detained in handcuffs (D/L and checked for tightness) and placed in the rear of my patrol car. Carland eventually calmed down and was taken out of handcuffs and sat on the curb waiting for her ride. Carland then got upset that her cigarettes were lost and began to loudly curse and yell again. Carland was advised that she was disturbing the patrons and children inside of Dewey Park and that her yelling and cursing was causing a public disturbance. Carland continued to curse and yell at which time she was arrested for disorderly intoxication.

While attempting to place Carland in the rear of my patrol car, she began to kick the window in attempts to break it. She was then removed from the car and hobbled with a leg wrap. While attempting to secure her in the rear for an additional time, Carland kicked me in my chest with both of her feet several times. Carland was successfully secured in my vehicle at which time she was able to get out of the hobble and begin to kick the window again. As I attempted to secure Carland, she proceeded to bite my right wrist leaving visible marks. After a brief struggle, Carland was finally secured and transported to Bethesda Hospital for medical clearance.

Based on the aforementioned facts, I find probable cause to charge Carland with Battery on a Law Enforcement Officer pursuant to F.S.S 784.07.1D and Disorderly Intoxication pursuant to F.S.S 856.011. Carland was transported to BBPD for processing and later TOT PBCJ.

This entire incident was captured via my BWC and photos of my injuries were taken and submitted into BBPD Evidence.
