#### **PROBABLE CAUSE**

On the above date and approximate time, I was in service in Palm Beach County. I was called to by PBSO to assist with a possibly impaired driver who was asleep behind the wheel with the vehicle in drive on westbound Foresthill Blvd and Congress Ave. Upon my arrival, I made contact with D/S Blackman 8396 who was out with a driver who was later identified by Florida DL as Alan Giuliano Grisetti DOB 3-28-1991. Upon contact, I spoke with the driver who was sitting on the median and asked him what happened. He advised nothing happened. I then asked him why his vehicle was stopped passed the stop bar and into the crosswalk and he advised that there was not reason. I then asked him why he had to be woken up by the Deputy and he advised that did not happen. I observed his speech to be slow, thick, and slurred and I observed him to have glassy watery eyes and there to be an odor of an unknown alcoholic beverage coming from his mouth area and breath. I asked him where was he going and he advised that he is going home. I then asked him for his ID and he was having difficulty locating his ID in his wallet and passed over it several times. He then handed me his concealed weapons permit and I advised him that I did not need that and advised him that I wanted to see his DL. After some time, the driver was able to locate the DL in his wallet and handed it to me. I asked him where he was coming from and he advised that he was coming from a friend's house. I then asked the driver if he would perform roadside exercises to check for impairment and the driver agreed. The driver advised that he does not have any medical problems, does not take any medication, and does not have any problems with his eyes that are not corrected by lenses.

Subject advised that he did not have any physical injuries that would prevent him from performing the exercise. Subject advised that he understood and did not have any questions. Used Solid white line. Subject did not count out loud. Subject used arms for balance. Subject took incorrect number of steps and took 25 steps on the first 9 heel to toe steps. Subject missed heel to toe on several steps. Subject stepped off of the line. Subject did not turn as instructed. Subject did not take return steps.

Subject was provided the instructions again and advised that he understood and did not have any questions. Subject used arms for balance. Subject missed heel to toe on several steps. Subject stepped off of the line several times. Subject took incorrect number of steps on both sets of steps. Subject did not count out loud.

One Leg Stand

Subject advised that he understood the instructions and did not have any questions. Subject raised left foot. Subject used arms for balance.

Subject placed foot on the ground several times. Subject did not count as instructed. Subject swayed during task. Subject did not look down as instructed.

#### Finger to nose

Subject identified left and right hand correctly and index fingers as well. Subject advised that he understood the instructions and did nominave any questions. Subject performed the task as follows: 1st left, left index finger to tip of nose. 1st right, right index finger to right side of nose then to tip of nose. 2nd left, left index finger to tip of nose. 2nd right, right pad of index finger to tip of nose. 3rd left, left pad of index finger to tip of nose. Observed subject to have eye lid tremors. Subject had to be told to keep eyes closed. Subject had to be told to return to the starting position every time.

Modified Romberg balance

Subject advised he understood the instructions and did not have any questions. Subject was advised to keep eyes closed. Observed subject to have orbital sway and eye lid tremors. Subject stopped task at approximately 33 seconds.

After roadside exercises were completed, the driver was placed under arrest for DUI and advised of this. The driver was searched and observed the driver to have a discolored tongue with a white film. The driver began to get more agitated and advised that I was ruining his career and that he just obtained his pilot's license and it was going to ruin his career. The driver continually advised during roadside exercises that I just wanted to take him to jail. Upon placing the driver in the rear of my marked patrol vehicle and fastening the seatbelt, the driver advised that he had to work in the morning and advised that he works for Palm Beach County as a Park Ranger. The driver was then transported to the Palm Beach County jail. Upon arrival, the driver was escorted to the Breath Alcohol Testing center and a 20 minute observation was conducted to ensure the driver did not take anything by mouth or regurgitate. #### **NARRATIVE:**

On Saturday, May 27<sup>th</sup>, 2017 at approximately 0345 hrs while in the area of Forest Hill Blvd and Congress Avenue, with in the incorporated Village Limits of Palm Springs, Palm Beach County, Florida, 33406 D/S J. Walker I.D. 28280 and I were approached by a concerned citizen who advised that there was a white 4DR passenger vehicle sitting in the intersection of Forest Hill Blvd and Congress Avenue. Per the concerned citizen the vehicle had sat through several green traffic signals. Per the concerned citizen the vehicle had been in the intersection for approximately 30 minute to an hour, he advised that he attempted to flag down several Palm Springs Police Officers however he was unsuccessful.

D/S Walker and I responded to the area and observed a white chevy cruze 4DR bearing Florida License Plate 123NAA stopped in the intersection of Forest Hill Blvd and Congress Avenue just east of the intersection. Upon turning around and getting behind the vehicle I observed the vehicle to be occupied one time. Upon approaching the vehicle I observed the driver/sole occupant to be a white male subject who was passed out behind the wheel of the vehicle with his head tilted back against the head rest, eyes closed, and mouth open. I noted that the vehicle was stopped in the cross walk. I noted that there was a handgun on the right front passenger seat of the vehicle.

At this time D/S J Walker observed that the door of the vehicle were unlocked. D/S Walker opened the passenger door and removed the firearm for Officer Safety. I then opened the drivers door at which time I observed an extremely strong odor of an unknown alcoholic beverage emanating from the drivers person. At this time I woke the

driver who opened his eyes looked at me and went back to sleep. I repeated this process three more times with the same results.

Upon getting the driver to exit the vehicle I asked him for his drivers license which he claimed not to have however upon asking him if he was the registered owner of the vehicle he stated that he was. Upon asking for his name and DOB he stated that his name was Alan Grisetti (date of birth 03/28/1991).

At this time based on my observation of Grissetti I believed he was operating a motor vehicle under the influence of an unknown alcoholic beverage there for I contacted Trooper L. Escaran I.D. 3335 of the Florida Highway Patrol D.U.I. Unit. Trooper Escaran later responded to the scene and conducted a D.U.I.
