On Sunday May 19, 2019 at about 1547 hours I was dispatched to 7699 Cherry Blossom Street, Boynton Beach, unincorporated Palm Beach County. This is the area of The Grove. I had been advised by dispatch that a male was calling in screaming that an elderly white male was following him screaming that he does not belong here. The male stated that the male drove into him and caused him to fall off his scooter. The male had told him he was on the board and part of security. Upon arrival I observed a white lexus to be at an angle and a scooter laying next to it. A younger black male was by the scooter and an elderly white male standing looking at him.												
I first spoke the the elderly white male, Alan Glinkenhouse. Alan stated he had the task of being on the security board here. He stated he pulled in to the gate off of Boynton Beach Blvd and observed a scooter that did not stop at the gate. He stated he followed the scooter all the way to the back of the community. He said the male on the scooter refused to stop for him. They stopped in front of 7699 Cherry Blossom Street when the male fell off the scooter.												
I next spoke with the younger black male, Raymond Golding. Raymond stated he lives in the community. He states he came into the community. He did not stop at the gate. He states the vehicle behind him started chasing him and yelling at him that he did not belong. He attempted to get away from the male by speeding up and running stop signs. He states he finally stopped and the male pulled up next to him and struck his left leg with his vehicle. He stated he was in fear for his life during this incident. I had Raymond give a recorded statement regarding this incident on video. The video will be flagged with this case number.												
PBCFR Station 47 responded and transported Raymond to Bethesda West for further treatment. See their run number 19-054304 for further information.												
I took photos of the scene and placed the sd card into evidence.												
Based upon the above investigation I find probable cause exists to charge Alan with one count of aggravated battery with a deadly weapon in violation of f.s.s. 784.045 1a2 as he did knowingly and intentionally chase and strike Raymond with his motor vehicle.
