## NARRATIVE:

On Tuesday 11/1/16 Agt. Fortwangler was conducting surveillance at 5936 Okeechobee Blvd, WPB, FL, the Meeting Place bar. This location is known for drug sales, confirmed by a recent investigation resulting in several arrests.

At approximately 2030 hours Agt. Fortwangler observed a black-male in his 40's-50's wearing a gray shirt, orange shorts and orange shoes, exit the front door of the bar. He entered the passenger side of a Red Kia Suv, which had just pulled up outside the front of the bar. The passenger was in the Kia for 15-20 seconds and exited. He went back the bar. The Red Kia then pulled out and drove towards Meridian Rd. I observed the Kia as it turned from Meridian Rd and traveled east on Okeechobee Blvd and identified the tag as BFXT92. This was the only vehicle in the area and was confirmed by Agt. Fortwangler as I got behind it. While in an unmarked vehicle (VIN 2G1WB57K991232843), with a certified speedometer, I paced the vehicle east on Okeechobee Blvd at 52 MPH in a posted 45 MPH. This vehicle I was using does not have an in-car camera. D/S White then got behind the Kia and activated her lights. The Kia turned north on Haverhill Rd and into a plaza next to Carvel and stopped in a parking space.

D/S White approached and identified the driver by FL DL as Alan Bernstein. I approached the passenger side. I began speaking with Alan and asked him where he was coming from. He told me he was going to stop by the bar, but when he got there, he changed his mind. I asked him if anything else happened while he was there and he said no. I then asked if he spoke with anyone at the bar and he said that someone did

approach him and asked him a question. I asked him if anyone got into his car and he said, "well, a guy I know Ty Dy got in for a minute". I know "Ty Dy" from previous encounters and his real identity as Milton Williams DOB 1/30/64. He is a known crack dealer at the meeting place bar and plantation community.

I did notice a odor of marijuana at the passenger side of the Kia. I asked Alan for consent to search him and his vehicle, which he clearly said was okay. I even asked him twice and he confirmed it was okay to search.

On the passenger seat of the vehicle was a camouflage back-pack. I confirmed with Alan that it was his. Upon searching the top lid pocket, I located a very strong smelling bud of marijuana, which was in a brown plastic bag. In the same compartment were 2 pieces of crack rock, which later field tested positive for cocaine. There was also a glass crack pipe present. Also in the backpack was a bottle of medication with Alan Bernstein's name. Before I showed Alan the marijuana I confirmed the bag was his. I then showed him the marijuana and he said that it was his. I then showed him the 2 pieces of crack rock and asked him, "can you tell me what this is". He said, "it looks like crack". I then took Alan into custody, handcuffs locked and checked and placed up front due to his structure. Computer check also had confirmed that Alan had a valid license and no arrest history.

D/S White provided Alan with Miranda, which he said he understood. Post Miranda Alan admitted to obtaining crack cocaine from Ty Dy. He told me he has known Ty Dy from the bar for over a year and that he has purchased crack and marijuana from him in the past. He said today Ty Dy fronted him the drugs as an "I owe you". Alan said the 2 pieces of crack had a value of \$20 each and the bud of marijuana was also \$20. With an old picture, I showed it to Alan and asked him if it was a picture of "Ty Dy" and he said yes, that he was 100% positive, confirming the identify of Ty Dy as Milton Williams. I was unable to produce a photo lineup in the field at this time.

Alan provided me with a sworn written statement confirming that he had obtained the crack and marijuana from "Ty Dy". He also provided me with Ty Dy's number from his cell phone, which was 561-506-0412. Since we had an active investigation, my focus was on Milton Williams. I decided to release Alan and file for charges of possession of cocaine, possession of marijuana and possession of drug paraphernalia.

At approximately 21:38 "Ty Dy" was observed getting into the passenger seat of a 4dr gold Toyota, FL tag 2039QJ. Agt. Fortwangler confirmed this was the same person, and was still wearing a gray shirt, orange shorts and orange shoes. I observed the Toyota as it exited the plaza onto Meridian Rd and then east on Okeechobee Blvd. D/S Biagiotti #7299 observed the driver and D/S White observed the passenger as it traveled east. Both subjects were not wearing seat belts. A traffic stop was conducted

on Haverhill at Stacy St. The driver was identified as Stephen Mccardell. The driver was identified as Milton Williams. Milton was detained and searched No drugs were located. Speaking to Stephen without Milton present, he said he was taking Milton to get more drugs.

The drugs and pipe were field tested and weighed and placed into PBSO evidence.
