Castineira was dispatched to Christine's nail salon located at 4077 Hood Road Palm Beach Gardens, Florida in reference to a fight in progress. The following was captured on my department issued body worn camera. Upon my arrival I made contact with the victim later identified by his Florida driver's license as Paul Martinsen Stewart who provided a sworn statement. Stewart was on the ground, laying on his back inside Great Clips located at 4073 Hood Road Palm Beach Gardens. Stewart had several lacerations on his feet, legs, knees, hands, head and face. Stewart advised that he was driving in his vehicle a white 2009 Honda Element bearing Florida tag (HVH3S) on Hood Road. Stewart stated that while driving, he got into an argument with a male later identified as Alan Richard Promades who was driving a silver 2013 Honda Pilot bearing Florida tag (682PCZ). Stewart advised that Promades "flicked him off" by putting up his middle finger while driving by. Stewart stated that he followed Promades into the parking lot of Frenchman's Crossing located at 4063 Hood Road Palm Beach Gardens. Stewart advised that he then got into a verbal argument with Promades outside of his vehicle. Stewart said that during that argument he left his car door open to his vehicle. Stewart advised that Promades noticed a knife that Stewart keeps inside his vehicle. Stewart stated that Promades grab the knife from inside Stewarts vehicle and attempted to take it out of the case while saying "this is illegal". Stewarts advised that he felt his life was in danger and began to grab Promades to attempt to take the knife from him. Stewarts stated that Promades punched him in the face and began to beat him up as he attempted to run away and yell for help. I then made contact with the suspect Alan Richard Promades who was identified by his Florida drivers license. Promades advised that he was driving on Hood Road when Stewart cut him off in traffic. Promades stated that he put up his middle finger at Stewart as he was driving by. Promades stated that he pulled into Frenchman's Crossing and parke.

his vehicle. Promades advised that Stewart then parked behind his vehicle and began to argue with him. Promades stated that while arguing with Stewart, Stewart produced the knife and attempted to stab him with the knife still in the case. Promades had a small laceration on his right eye and inside lip. Promades also had a cut on his left knuckle.

I then made contact with Zander Alain Promades (11 years old) who is the son of Alan Richard Promades. Zander Alain Promades was identified by his name and date of birth and provided a sworn statement. Zander Alain Promades advised that he was inside the vehicle and went outside the vehicle during the altercation. Zander Alain Promades stated that Stewart had cut them off in traffic. Zander Alain Promades advised that Stewart parked behind their vehicle and began to argue with his father. Zander Alain Promades stated that his father Alan Richard Promades saw a knife that was inside Stewarts vehicle. Zander Alain Promades advised that his farther Alan Richard Promades reached inside Stewarts vehicle and grabbed the knife. Zander Alain Promades stated that he heard Stewarts say, "don't touch it". Zander Alain Promades stated at that point a fight began.

Officer Hayashi ID 408 advised that he made contact with an elderly female who stated she wanted to remain anonymous. The elderly female stated that she saw Alan Richard Promades on top of Stewart beating him up as he was yelling for help.

I again made contact with Paul Martinsen Stewart who stated that he will prosecute for the crimes committed. Palm Beach Gardens Fire Rescue arrived on scene and both males refused treatment. Due to the statement made by witnesses and the injuries to Stewart. Alan Richard Promades was placed into handcuffs which were checked from proper spacing and double locked.

Based upon my investigation, there is probable cause to arrest Alan Richard Promades with (1) count of burglary to an unoccupied conveyance, pursuant to Florida State Statute 810.02(4)(B) and (1) count of simple battery, pursuant with Florida State Statute 784.03(1)(A)(1). Promades was transported to the Palm Beach Gardens police station for processing, and later to the Palm Beach County jail for booking without incident.
