P R O B A B L E C A U S E S T A T E M E N T	On 3/28/18 I was dispatched to 5700 W Glades (Macy's) in reference to Loss Prevention having a female in custody for shoplifting. Upon arrival, I met with Loss Prevention Investigator Marie Bros.					
	Investigator Bros informed me she conducting surveillance of the store via CCTV when she noticed a female, later identified as Alba Jimenez, grab two chocolate bars from a shelf on the second floor of Macy's and conceal them in her white bag. Investigator Bros then observed Jimenez take the escalator down to the first floor where she selected two Pure Grace Beauty Products from the impulse department. Investigator Bros then went out to the store to conduct floor surveillance where one of her loss prevention partners informed her that Jimenez took the escalator back up to the second floor and was unboxing Pure Grace Beauty merchandise and concealing it in her white bag. Jimenez then went back down to the first floor and began to walk towards the mall exit passing all points of sale and making no attempt to purchase any of the products. Investigator Bros then escorted Jimenez back to the loss prevention office. While in the office, they recovered 10 bars of chocolate, two containers of perfume, three pairs of earrings, and two rollerballs of perfume. All the items stolen totaled \$236.50 worth of merchandise.					
	I then met with Jimenez and advised her of her constitutional warnings which I read from my department issued Miranda Card. She stated she understood her rights but because she had a strong accent and her primary language was Spanish, I let her read her Miranda rights in Spanish. She stated again that she understood her rights and wished to speak to me.					
	I asked Jimenez what happened and she advised she made a mistake and stole the items because the lines to pay were too long and she did not want to wait. She also informed me she went around the store and placed all the stolen items inside her white
