NARRATIVE: I AM PART OF A NATIONAL TASK FORCE KNOWN AS THE SOUTH FLORIDA INTERNET CRIMES AGAINST CHILDREN (ICAC). THIS TASK FORCE INVESTIGATES INTERNET CRIMES AGAINST CHILDREN, CHILD EXPLOITATION AND RELATED CASES.

ON 05/02/2017, I RECEIVED A NCMEC CYBERTIP FROM THE SOUTH FLORIDA ICAC TASK FORCE. THE CYBERTIP WAS REPORTED BY SKOUT.COM AND IN REFERENCE TO A SEXUALLY EXPLICIT CONVERSATION BETWEEN AN ALLEGED 14 YEAR OLD MALE (VICTIM) AND A 67 YEAR OLD MALE (SUSPECT). THE CONVERSATION BEGAN ON 04/12/2017, IN WHICH THE SUSPECT ASKED THE VICTIM IF HE WAS YOUNG AND INFORMED THE VICTIM THAT HE LIKED "REAL YOUNG." WHEN THE VICTIM RESPONDED HE WAS 14 YEARS OLD THE SUSPECT RESPONDED IN STATING HE WAS 67 YEARS OLD AND LIVED IN FLORIDA. THE SUSPECT ASKED THE VICTIM IF HE "EVER HAD A OLD GUY SUCK YOUR DICK?" WHEN THE VICTIM RESPONDED "NOPE", THE SUSPECT INFORMED THE VICTIM, "I WOULD SUCK YOU. WOULD YOU SUCK ME? I'D LIKE TO SEE YOUR YOUNG DICK AND BALLS. YOU ARE HOT, I'D EAT YOUR ASSHOLE." THE SUSPECT THEN ASKED THE VICTIM TO SEND HIM NUDE IMAGES OF HIMSELF, IN WHICH THE VICTIM COMPLIED. THE SUSPECT INTURN SENT THE VICTIM 3 PORNOGRAPHIC IMAGES OF A PENIS.

IN GATHERING INTEL, SUBPOENA RESULTS FOR THE SUSPECT'S IP ADDRESS OF 71.196.70.43 RETURNED TO SUBSCRIBER, ALBERT MOZEK, RESIDING AT 198 CAMBRIDGE I, WEST PALM BEACH, FL. SUBPOENA RESULTS FOR THE VICTIM'S IP ADDRESS OF 24.125.139.239 RETURNED TO SUBSCRIBER [REDACTED], [REDACTED].

FURTHER INTEL GATHERED IDENTIFIED THE VICTIM (HERBY KNOWN AS [REDACTED]) AS A 12 YEAR OLD MALE, RESIDING IN [REDACTED] WITH HIS MOTHER, [REDACTED]. ON 05/17/2017, CONTACT WAS MADE WITH DETECTIVE LEACH, OF THE GWINNETT COUNTY POLICE DEPARTMENT IN [REDACTED] REQUESTING ASSISTANCE WITH THE INVESTIGATION. PER MY REQUEST, DETECTIVE LEACH MADE CONTACT WITH [REDACTED] AND [REDACTED]. IN A TAPED STATEMENT, "[REDACTED]" VERIFIED HE HAD A SEXUALLY EXPLICIT CONVERSATION WITH MOZEK ON SCOUT.COM, AND THAT MOZEK HAD SENT HIM 3 PORNOGRAPHIC IMAGES OF A PENIS, WHICH "[REDACTED]" BELIVED TO BE OF MOZEK. "[REDACTED]" FURTHER INDICATED HE HAD STOPPED TALKING TO MOZEK WHEN MOZEK STATED HE WOULD TRAVEL TO MEET "[REDACTED]" IN GEORGIA TO ENGAGE IN SEXUAL ACTIVITY.

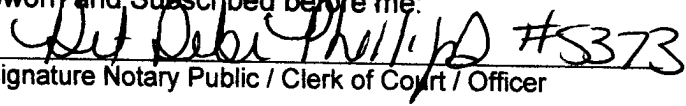

NARRATIVE CONTINUATION

ON 06/19/2017, DETECTIVE DEBI PHILLIPS AND I MADE CONTACT WITH ALBERT MOZEK AT HIS RESIDENCE LOCATED AT 198 CAMBRIDGE I, WEST PALM BEACH, FL. POST MIRANDA MOZEK AGREED TO SPEAK WITH ME. I INFORMED MOZEK OF THE EVIDENCE OBTAINED CONFIRMING HE HAD COMMUNICATED WITH "████", A 12 YEAR OLD MINOR MALE VIA SKOUT.COM IN A VERY SEXUALLY EXPLICIT MANNER, AND HAD ATTEMPTED TO SOLICIT THE "████" FOR SEX. MOZEK ADMITTED TO CHATTING WITH THE MINOR AND ADMITTED HE SENT PORNOGRAPHIC IMAGES OF HIMSELF TO THE MINOR. MOZEK STATED, "I DIDN'T REALIZE IT WAS A LITTLE KID." MOZEK EXPLAINED HE CHATTED WITH THE MINOR BECAUSE HE MUST HAVE "HAD A FEW BEERS." MOZEK DIDN'T DENY HE WANTED TO TRAVEL TO MEET THE MINOR FOR SEX BUT STATED HE WAS JOKING. MOZEK STATED HE USED HIS IPHONE TO ACCESS THE SKOUT APPLICATION TO CHAT. MOZEK DENIED CHATTING WITH ANY OTHER CHILDREN.

BASED ON MY INVESTIGATION, ALBERT MOZEK WAS PLACED UNDER ARREST AND CHARGED WITH 1 COUNT OF SOLICITATION OF A CHILD, IN VIOLATION OF F.S.S.847.0135(3)(A); 1 COUNT OF MISUSE OF A 2 WAY COMMUNICATION DEVICE, IN VIOLATION OF F.S.S. 934.215; AND 3 COUNTS OF TRANSMISSION OF MATERIAL HARMFUL TO A MINOR, IN VIOLATION OF F.S.S. 847.0138(2).
