The white male driver then exited the front seat of the Nissan and approached the front passenger side of the unmarked vehicle. I rolled down the front passenger's side window and upon making contact I was able to immediately recognize the white male as Albert J. Cox (W/M D.O.B. 04/27/1951) from previous review of his Florida Driver's License (D.A.V.I.D.) photograph.  Conversation ensued and Cox further explained how he cannot take any chances, refereeing to meeting new clientele because of fear in being detected and apprehended by law enforcement. He then confirmed that I wanted to purchase one (1), referring to one (1) bag of powder cocaine. Cox then reached into this front shirt pocket (on left side) and removed a small, clear zipper bag containing a white powdery substance. Based on my knowledge, training, and experience I was able to immediately recognize the substance inside of the clear bag to be powder cocaine.  I handed Cox \$60.00 worth of PBSO investigative fund monies. Cox further advised that he had several individuals in the area that he was meeting and dealing with, that's why he directed me to meet in this area.  After the narcotics transaction was completed Cox reentered the front driver's seat of the silver Nissan vehicle. Around 1356 hours I left the area and communicated to assisting personnel that the narcotics transaction was completed. Once at an undisclosed location, the suspected powder cocaine field tested positive for cocaine utilizing a Cobalt test kit and negative for opium/amphetamine type compounds utilizing a Marquise test Kit; it had a total package weight of 0.8 grams. The powder cocaine inside of the small, clear zipper bag was sealed into an evidence bag and submitted it into PBSO District 7 evidence.  Further investigation revealed that the silver Nissan Altima vehicle (bearing FL tag 213YTE) was registered to EAN Holdings LLC. and rented during this timeframe to Albert Cox.  Based on the above investigation, it was determined that Albert Joseph Cox (D.O.B 04/27/1951) was in
