Dejesse was placed under cath and gave the following sworn statement. He stated while on his way home he noticed a brown SUV stopped on the side of the road. He stated he saw a male, later identified as Albert Giraitis, cut of the vehicle and at the front passenger side with the door open. Dejesse said he could see Giraitis arguing with a female occupying the passenger seat. The passenger was later identified as Dwana Finelli. Dejesse made a u-turn to go back to help. As he approached the vehicle Dejesse stated he saw Giraitis strike Finelli in the face but was unsure if it was with an open hand or a closed hand. When Dejesse made contact with both parties, he stated Finelli was crying and holding her jaw.

I made contact with Giraitis. Giratis was read his Miranda Warnings from a printed card. He stated he and his fiancé who have been together for 6 years were in a verbal altercation. He stated he stopped his vehicle to let Finelli out. He stated he walked over to the passenger side, opened the door and reached into the vehicle. He said he reached across Finelli to unbuckle her seat belt. Post Miranda he stated while he reached inside of the vehicle they started "swatting flies." Giraitis stated they were both swinging their hands at each other while he was reaching inside of the vehicle. He then said he wasn't sure if he hit her but if he did then it was not intentional.

I made contact with Finelli. She was placed under oath and gave the following sworn statement. She refused on scene medical attention. Immediately I noticed redness on her left cheek and neck area while the rest of her face was not red. Finelli stated while on her way home she noticed a small bag was missing and stated Giraitis may have lost it. They began arguing over who lost the bag. She stated he stopped the vehicle on the side of the road. She said he exited the vehicle and walked over to the passenger side, opened the door and tried to unbuckle her seat belt. She stated she tried to stop him from taking the seatbelt off and he struck her with his open right hand on her left cheek. She said that is when the witness (Dejesse) walked up to the vehicle and separated them.

Finelli was provided with a case number, a victim's rights pamphlet and a victim's notification form.

I find probable cause to charge Albert Giraitis with 1 count of simple battery as he did actually and intentionally touch or strike Dwana Finelli against her will. F.S.S. 784.03(1)(A)(1).
