On May 10, 2019, at approximately 2:53 pm, I D/S P. Sanchez #24967 was on patrol in the area of Bowman St/S Haverhill Rd, Greenacres, Palm Beach County, Florida 33463. I was driving in a PBSO issued unmarked vehicle, which was equipped with red and blue emergency lights as well as siren. I was wearing a black tactical vests, which prominently displays the word "SHERIFF" in green lettering on the front and back of the vest, along with sheriff badge, gun belt and equipment, clearly identifying me as a PBSO Deputy. I visual observed and paced a black Mitsubishi Lancer bearing FL Tag KBLM30 (VIN:JA3AU86U38U009862) traveling at over 45 MPH in a 25 MPH zone while traveling westbound on Bowman St towards S Haverhill Rd. The vehicle turned northbound on S Haverhill Rd and I activated my red and blue lights and conducted a traffic stop on the vehicle and it stopped at the intersection of Second St/S Haverhill Rd. The driver and sole occupant of the vehicle was identified by his FLDL as W/M Alberto D. Pizarro (06/15/1979). Upon approaching the passengers side front window I immediately smelled the odor of marijuana emitting from the vehicle and observed in plain view a marijuana cigarette on the driver seat floorboard. I also observed a clear green plastic container in plain view on the passengers seat with small pieces of green leafy substance inside. Pizarro was asked to exit the vehicle. I then detained Pizarro in handcuffs that were checked for fit and double locked. As I began to search Pizarro, he spontaneous uttered, "The only thing in there is a joint on the floor, I need to get back home to care for my father." When I searched the vehicle I observed one marijuana cigarette fill with marijuana on the floorboard of the drivers area. Located inside of the center console was a black vaporizer pen with THC Oil cartridge. In the front passengers seat a clear green plastic container with marijuana residue inside used to transport marijuana. The suspected THC Oil was field tested with a Sirchie #8 Duquenois field test kit which yielded a positive test result for marijuana and weighed a total of 1 gram. The marijuana cigarette was field tested with a Sirchie #8 Duquenois field test kit which yielded a positive test result for marijuana and weighed a total of 1.2 grams. The clear green plastic container, black vaporizer pen with THC Oil cartridge, and marijuana cigarette were submitted into PBSO District 16 evidence lockers for trial purposes. Based on my investigation and evidence there is probable cause to charge W/M Alberto D. Pizarro (06/15/1979) with Possession of Schedule I Substance (THC Oil), pursuant to F.S. 893.13(6a), Possession of Paraphernalia, pursuant to F.S. 893.147(1b), and Possession of marijuana under 20 grams, pursuant to F.S. 893.13(6b). Pizarro was issued a written warning for speeding. Pizarro was taken to PBSO D16 for processing then to the PBC Jail.
