P R O B A B L E	On May 23, 2019, at 2150 hours, I was traveling eastbound at approximately 2000 W Yamato Road in my marked Boca Raton Police patrol vehicle when I observed a white Hyundai Accent bearing Florida tag KMKJ53 in the outside turn lane to go northbound on N Military Trail. I ran the license plate and the registration came back as expired as of 04/11/2019. After running the license plate, I conducted a traffic stop and came to a final stop at 5200 N Military Trail. I approached the passenger side of the vehicle and made contact with the registered owner of the vehicle and sole occupant of the vehicle, Alec Ross Kravitz. I informed Kravitz that his registration was expired and asked for his driver's license, registration, and proof of insurance. Kravitz provided all three and Kravitz was identified by his Florida driver's license; K613016951310. The registration paperwork confirmed his registration is currently expired.									
	While speaking with Kravitz during the traffic stop, I smelled the odor of marijuana emanating from the vehicle. I contacted BRPD Dispatch and requested backup. Officer Fabelo later arrived and I informed him of the odor of marijuana emanating from the vehicle. I immediately recognized this odor based on my training, knowledge, and experience. I then went and spoke with Kravitz and informed him that during the traffic stop, I smelled marijuana emanating from the vehicle of the car. I asked Kravitz if there was any reason why I would be smelling the odor of marijuana coming from the vehicle and he stated no. Officer Fabelo and I had Kravitz step out of the vehicle, at which point I searched him and did not find any contraband located on his person. Officer Fabelo stood by with Kravitz while I searched the vehicle. Inside of the vehicle I found the following: In the driver door panel I located a silver vaporizer pen with a clear capsule with a yellowish/brown wax substance inside of the capsule. Based on my training, knowledge, and experience, I believed the substance to be THC oil. I finished searching the front driver side of the vehicle and began to search the rear driver side of the vehicle. On the floor of the rear driver side of the vehicle, I located a black string backpack which contained the following: six separate plastic bags which contained

a large quantity of a green leaf substance that was located in a clear/red container and a green glass jar, one small yellow envelope with a white piece of paper with a yellow wax substance, a small white envelope with a piece of paper with a yellow wax substance, two small black boxes with two of the same clear capsules with a yellowish brown wax substance inside of the capsule. Based on my training, knowledge, and experience, I believed the green leaf substance to be marijuana, the yellowish/brown wax substance to be THC oil, and the yellow wax paper to be THC wax. Inside the backpack I also located another clear/red container with what appeared to be a glass blue pipe that is used to smoke marijuana and a black digital scale. I observed the pipe and it smelled as if there was marijuana that was previously smoked in it and had a small amount of residue in the bowl of the pipe. It should be noted that at the time of searching the black backpack, Officer Fabelo read Kravitz his constitutional warnings from his department issued Miranda card and Kravitz verbally stated he understood his rights and wished to speak with me. When I spoke to Kravitz he informed me of the following: He advised he wanted to be honest with me and tell me exactly what I was going to find in the vehicle. He stated that the black backpack in the rear driver side of the vehicle was his and that inside the bag was approximately one ounce of marijuana for personal use. He also stated the vaporizer pen with the yellowish/brown wax substance in the capsule was his and that it is THC oil, which he forgot was in the vehicle. After I finished searching the vehicle I asked Kravitz about the two clear capsules with the yellowish/brown wax substance and he stated they were his and those also contained THC oil. I asked Kravitz about the two small envelopes with the yellow wax paper and he advised they were also his and they contained THC wax. I asked Kravitz about the blue pipe and he stated it was his and he has been smoking marijuana since he was fourteen years old. I asked Kravitz about the black scale and he informed me that he uses the scale to weigh the marijuana that he purchases to make sure he obtains the right amount of marijuana. Kravitz told me that he came from Coral Springs, Florida, from hanging out with some friends of his and that he was going to visit a friend located in Mizner Court, 6503 N Military Trail, Boca Raton, Florida to return some computer parts that he left with Kravitz. Kravitz did not provide me with the names of the individuals he was hanging out with. It should be noted that all of the evidence was submitted into BRPD evidence. After completing my investigation, Alec Kravitz is being charged with two counts of of F.S.S 893.13(6A) Possession of Hashish/Oil, one count of F.S.S. 893.13(1A2) Possession of Marijuana with intent to sell, and three counts of F.S.S. 893.147(1) (A) Possession of Paraphernalia. Subsequently, Kravitz was taken into custody and transported to Palm Beach County Jail.
