NARRATIVE:

On Monday, February 11th, 2019 at approximately 0324 hrs while conducting stationary radar in the area of Haverhill Rd and Grant Lane in unincorporated West Palm Beach, Palm Beach County, Florida, 33415 I observed a blue 2DR passenger car traveling north bound at a high rate of speed.

I visually estimated the vehicle to be traveling at approximately 60mph in a posted 40mph zone. I activated a stalker dual radar unit and immediately observed a high audio doppler tone. I observed the visual indicator to be 63mh in a posted 40mph zone.

I then turned around and proceeded to catch up to the vehicle which was now making a left on to Gun Club Rd from Haverhill Rd. Upon turning left onto Gun Club Rd from Haverhill Rd I observed the vehicle making a u-turn on Gun Club Rd to travel back east bound.

I proceeded to get behind the vehicle which was now in the east bound left turn lane of Gun Club Rd approaching Haverhill Rd. I observed the Florida License plate Y73GUB attached to the vehicle.

I initiated a traffic stop on the vehicle which was a blue chrysler crossfire 2DR as the vehicle traveled north bound on Haverhill Rd toward Southern Blvd. The driver pulled into the driveway of 150 S Haverhill Rd.

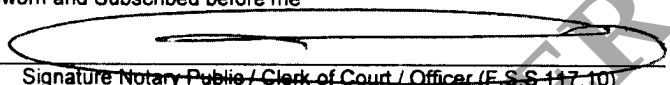
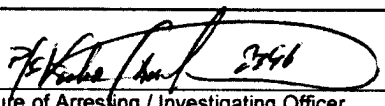
NARRATIVE CONTINUATION

I noted that the driver immediately grabbed a gatorade bottle and took a single drink from it upon stopping his vehicle. I made contact with the driver at the drivers side window where I immediately observed a strong odor of an unknown alcoholic beverage emanating from the driver's person.

I informed driver of the reason I had stopped him at which time he stated that someone was chasing him. I requested his drivers license, registration, and proof of insurance, he provided his California Drivers License which had his photograph attached and identified him as Alejandro Lara Escelara.

Lara Escelara was unable to locate his insurance and registration at this time he fumbled and search through his vehicle for the paperwork. I noted that his eyes were red and watery and his speech was slurred when he spoke.

Based on my observations I believed Lara Escelara was operating a motor vehicle under the influence therefore I contacted D/S J. McCoy I.D. 33108 of the Palm Beach County Sheriff's Office District 1 Road Patrol Division who responded to the scene and conducted a D.U.I. Investigation.

OBSERVATION OF DRIVER:

When I initially observed Lara, he was standing outside his blue 2 door Chrysler Crossfire bearing Florida tag #Y73GUB. I observed Lara swaying from side to side approximately 2-3 inches. As I was talking to Lara, I observed his eyes to blood shot red and glassy. Lara speech was also extremely slurred as he spoke. I relocated Lara to the front of my vehicle which was located on Haverhill Road, south of Southern Blvd.

As Lara was walking, he was stumbling over his feet as he was loosing his balance.

DRIVER'S STATEMENTS:

Lara told me that he was coming from a party located in Pahokee and he had just dropped off his friend near S Military Trail & Melaleuca. Lara told me that he had 5 Corona's earlier in the day and was currently on his way to Wellington.

ODORS:

I was able to smell an unknown alcoholic beverage coming from Lara's mouth as he spoke.

ATTITUDE: Calm, forgetful, cooperative

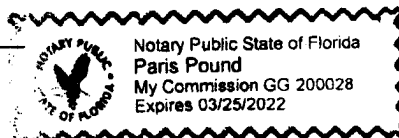

Other Observations:

WALK & TURN:

Can't keep balance while listening to instructions (Lara was swaying approximately 2-3 inches from side to side as he was standing). Starts exercise to early (Lara insisted on starting the exercises before I could finish explaining it to him. I had to remind him several times not to start until I say so). Forgets instructions (Lara forgot the instructions while he was mid way through). Raises arms over 6 inches (Lara raised both his arms at times over 6 inches for balance as he performed the exercises). Steps off line and does not walk heel touching toe (Lara stepped off the line and missed heel to toe on steps 4, 5, 7 and on steps 2, 4 5, and 6 on the way back.) Improper amount of steps (Antonio took 11 steps during the 1st attempt and 12 steps on the way back even though he was instructed to only take 9.)

ONE LEG STAND:

Can't keep balance while listening to instructions (Lara was swaying approximately 2-3 inches from side to side as he was standing). Improperly counts (Lara stated "2001, 2002, 2003, 2004, 2005, 2006, 2007 then stopped). Does not raise foot off ground 6 inches (Lara only raised his foot raised approximately 3-4 inches instead of 6). Does not keep foot off ground for 30 seconds (Lara put his foot down after approximately 7 seconds during this 1st attempt and 8 seconds).

FINGER TO NOSE:

Can't keep balance while listening to instructions (Lara was swaying approximately 2-3 inches from side to side as he was standing). Starts exercise to early (Lara insisted on starting the exercises before I could finish explaining it to him. I had to remind him several times not to start until I say so). Index finger does not touch tip of nose (Lara's left index finger touched the top of his top lip during the 1st attempt, 3rd and 5th attempt. His right index finger touch the top of the his nose during the 2nd, 3rd and 5th attempt.

ROMBERG ALPHABET:

Can't keep balance while listening to instructions (Lara was swaying approximately 2-3 inches from side to side as he was standing). Doesn't keep eyes closes (Lara had his eyes open during the majority of the exercise). Head not tilted back (Lara's head was not tilted back during this exercises).

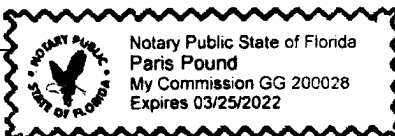
