On 9/7/2016 at 09:15hrs I responded to 10704 AVENIDA SANTA ANA in unincorporated Boca Raton, FL. 33498 in reference to a domestic dispute in progress. Upon arrival I met with W/M Alessandro Faria who was standing outside of his residence in the driveway. Alessandro was upset and had red stains of what appeared to be blood on the front of his shirt. Alessandro completed a sworn written statement and told me the following: Alessandro has been having ongoing verbal arguments in the past with his wife W/F Luciana Faria. Earlier this morning he had a verbal argument that became physical with his wife W/F Luciana. The argument was about Alessandro having an affair with a unknown women while being married to Luciana. While inside the master bedroom Luciana confronted Alessandro about the incident and Alessandro became upset and did not want to speak with her. During the argument Alessandro and Luciana were yelling and verbally abusive towards each other. Alessandro hit Luciana in the facial area with his hands. Luciana then exited the master bed room into the living room area in attempt to get away from Alessandro. Luciana was upset and started breaking several glass items in the living room. Alessandro entered the living room area and grabbed Luciana by the arms and throws her into the couch. Alessandro then sat on top of Luciana while she was on the couch. Their son W/M Lucas Carvalho observed Alessandro sitting on top of Luciana while she was yelling for someone to help her. Lucas was able to separate Alessandro and Luciana to end the physical confrontation. Due to the several items that Luciana had been broken inside the home Alessandro openly admitted to throwing Lucian pet cat towards the front door while the door was open in order to teach Luciana a lesson. Alessandro suffered bruises on his front right facial area caused during by the physical confrontation with Luciana.

While on scene Luciana was crying and refused to provide any written statement about the incident. Luciana suffered bruises on the neck area and a laceration on her right little finger. I then made contact with witness Lucas who completed a sworn statement and told me the following: He observed his parents physically fighting in the living room. Lucas came between Alessandro and Luciana to stop them from fighting. Alessandro was upset at Luciana and throws her pet cat outside towards the front lawn with his hands. The cat was not injured during the incident and did not require medical attention. I then made contact with witness Brenda Jorge who completed a sworn written statement and told me the following: Brenda observed her father Alessandro strikes Luciana in the facial area with his hands while she was in living room area. Brenda heard Alessandro state to Lucian that he was going to "kill the cat."
