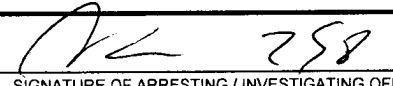

On the 27 day of October, 2016 at 01:14 (Specifically include facts constituting cause for arrest.) On October 27, 2016 at approximately 0027 hours, I was on a routine patrol at Blue Martini Bar located at 6000 W Glades Road. Officer Coronado arrived on scene as a backup officer and we advised Boca Raton dispatch that we would be patrolling the area on foot. Once on scene, I noticed a suspicious 2008 Blue BMW sedan bearing Florida tag #933MUM in the southern parking lot with its lights on. Officer Coronado and I monitored the vehicle parked for several minutes and noticed it was occupied. It should be noted the area is known for drug activity. Officer Coronado and I walked up to the vehicle to make a consensual encounter. I observed a white male later identified as Robert Lewis in the driver's seat and a white female later identified as Alex Deutsch in the passenger seat. I observed through the window that Lewis was using two white cards, making a line, with a white powdery substance on top of a blue container top. It should be noted the blue container was in the center console in between Lewis and Deutsch. As I flashed my flashlight at Lewis, he immediately dropped the cards and placed his right hand on the white powdery substance and began smearing it. Officer Coronado advised that Deutsch had a rolled up dollar bill in her right hand and was making furtive movements in attempt to conceal it in her purse. Due to my training and experience, I immediately recognized the white powdery substance used to make a line to be cocaine. I then asked Lewis and Deutsch to open the door and step out of the vehicle. See Officer Coronado's supplemental report for further information. I then searched the vehicle. I found the white powdery substance on top of the blue container top in the center console. Next to the powdery substance was two white cards. Inside a brown purse in the passenger seat was the rolled up dollar bill that Officer Coronado saw Deutsch conceal. No other contraband was located in the vehicle. Next, I read Lewis and Deutsch their Constitutional Warnings from a BRPD issued Miranda

card and they advised that they understood their rights and would answer our questions without an attorney present. Lewis admitted that he knew the white powdery substance was cocaine. Lewis advised he was using the cards to make a line so that they could snort the cocaine. Lewis stated he would take all the blame and that Deutsch had nothing to do with it.

I then spoke with Deutsch separately. Deutsch advised she was in the vehicle and knew that Lewis was making a line with the cocaine. Deutsch stated she knew the cocaine that Lewis using was illegal. Deutsch advised she took a rolled up dollar bill off of the blue container in attempt to conceal it. Deutsch advised she did not realized what she did but advised it was a natural reaction to hide the dollar bill from the police. Deutsch advised they were going to use the dollar bill to snort the cocaine.

I field-tested the cocaine with Quick Check test kit (one use only). The field test was positive for cocaine by turning blue. I placed the white powdery substance on a digital scale and it weighed .1 grams.

Based on the above information, Robert Lewis was placed under arrest and is being charged with Possession of Cocaine per F.S.S. 893.13(6A) and Possession of Paraphernalia per F.S.S. 893.147(1) for the two white cards used to make a line with the cocaine. Alex Deutsch was also placed under arrest and is being charged with constructive Possession of cocaine per F.S.S. 893.13(6A) and Possession of Paraphernalia per F.S.S. 893.147(1) for the 1\$ bill used for cocaine. The cocaine, two cards, 1\$ bill were turned into Boca Raton Evidence. Lewis and Deutsch were taken to BRPD Booking then transported to Palm Beach County Jail. Lewis' vehicle was towed by Emerald Towing. No further action taken by this officer.
