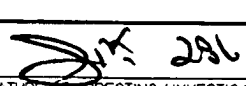

P R O B A B I L E	On 09-30-2018 at approximately 2210 hours, I responded to Beach House Recovery (13201 US Highway 1) in reference to a female who was "out of control" inside the facility. I arrived on scene and observed the female now outside yelling and screaming at staff members and other patients in the facility.						
	I met with complainant Marvin who advised me she was out of control and making everyone inside uncomfortable. The female was identified by staff members as Alexa B. Bilodeau w/f dob 01-25-1999 from Maine. A. Bilodeau advised she will calm down and police were not needed. Staff members agreed and advised police to leave.						
	Approximately five minutes later, they called back with the same concerns. A. Bilodeau was outside upon arrival and still screaming and belligerent. Marvin stated they conducted a PBT breath test on her at approximately 2100 hours, and she was slightly over a .100 BAC. Staff, as well as A. Bilodeau admitted to drinking an unknown alcoholic substance.						
C A U S E	Based on A. Bilodeau being a public nuisance and danger to other nearby, she was placed under arrest for Disorderly Intoxication as per FSS 856.011. She was transported to the Juno Beach Police department for completion of paperwork, then transported to the Palm Beach County Jail. The entire time She was loud, extremely belligerent and using several profanities towards Police.
