VICTIM # 2 STATE OF FLORIDA. On 10/15/2017, I responded to 5820 W Glades Rd (Nordstrom) in reference to a shoplifting. Upon arrival, I met with Loss Prevention officer Danyell Leboff who had a w/f in custody for shoplifting. Leboff stated she witnessed Alexa Leigh take three items from the jewelry department. Leboff stated she witnessed Leigh take two bracelets and place them on her right wrist. Leboff then witnessed Leigh ball up a necklace and place it in the Nordstrom bag, Leigh was carrying. Leboff witnessed Leigh exit through the east doors, passing all points of sales. The items taken were a Silver Kendra Scott bracelet (\$70.00), Gold Kendra Scott bracelet (\$70.00) and a Gold Necklace (\$75.00) for a total loss of \$215.00. All items were recovered from inside of the Nordstrom bag which was in Leigh's possession. A photo of the merchandise was taken and submitted into evidence. Leigh was read her constitutional warnings by Officer Fong (763) and agreed to speak to us. I asked Leigh what was going on and she said, "I did it." When I asked did what? She stated I took those items, as she pointed to the counter with the merchandise recovered from her Nordstrom's bag. Leigh stated she did it because she was being defiant and was acting out due to family issues. Officer Deen (768) responded for a search of Leigh's person and discovered two clear capsules containing a brown powdery substance along with a white pill. I asked Leigh what the items were and she stated the two clear capsules were Heroin and the white pill was Xanax. The Items were located inside of Leigh's left bra.

I searched Leigh's black purse and located a box of cigarettes which contained a white substance wrapped in clear plastic inside of the box. When I asked Leigh what the substance was, she stated Cocaine. I then continued to search her purse and located inside the left inner pocket, a clear capsule with a brown substance inside. I asked Leigh what the contents of the capsule were and she stated it was Heroin. I also located in the inner right pocket another clear capsule with a brown substance inside; Leigh again stated it was Heroin. I also located in the center open purse area another clear capsule with a brown substance inside. Leigh stated again the substance inside the clear capsules was Heroin. I called poison control; call number (M3569677), to identify the white pill and spoke with Michael Hasyn (ID106190) who stated the pill was 2mg Alprazolam. The five clear capsules containing the brown substance were weighted for a total of .3 grams and were submitted into BRPD evidence for testing. The white substance wrapped in a clear plastic baggie was tested, using the department issued Quick Test Kit, and tested positive for cocaine (blue) with a weight at .3 grams with the baggie. Based on my investigation Alexa Leigh is being charged with F.S.S. 812.015(1D) Petit Theft, F.S.S. 893.13 (6A) Possession of Cocaine, F.S.S. 893.13 (6A) Possession of Heroin, F.S.S. 893.13 (6A) Possession of Alprazolam. Leigh was arrested and trespassed from the store by Leboff. Leigh was processed at BRPD, then TOT CJ. The photo of the merchandise, the receipt of the merchandise and Leboff's written statement were all submitted into BRPD evidence.
