On Tuesday, January 31, 2017, at approximately 1925 hours, I responded to 2953 Fontana Place within the incorporated Village of Royal Palm Beach, in Palm Beach County, Florida 33411 in reference to a domestic battery.

Prior to arriving at the residence, I made contact with Alexa Perry, who was waiting in her vehicle down the road from the residence. Alexa stated she drove her mother, Lydia Stevens, home from spending the day together. Alexa stated her sister, Andrea Stevens, ran out of the residence as soon as the vehicle entered the driveway and began yelling at Alexa about dropping Lydia off late. Alexa stated she then went to get Lydia's wheelchair from the vehicle's trunk for their mother when Andrea pushed Alexa's head with her hand. Alexa stated she then pulled Andrea's hair out of self defense and brought her to the ground. Alexa stated the physical altercation then continued on the ground. Alexa stated the incident occurred in the presence of her children ([REDACTED]) who were inside of her vehicle.

Alexa stated she had scratches on her arms from the physical altercation, but refused medical treatment. I observed superficial scratch marks on the inside of Alexa's forearms and damage to her fingernails.

I then made contact with [REDACTED] at the residence. [REDACTED] stated she went outside the residence and confronted Alexa about bringing Lydia home late. [REDACTED] stated Alexa exited the vehicle to get the wheelchair out of the trunk, but then attacked her without being provoked. [REDACTED] stated Alexa grabbed her hair and pulled her to the ground where she punched her in the face and dragged her along the ground. [REDACTED] stated the altercation continued while she was on the ground and Alexa kicked her in the face.

[REDACTED] showed me the injuries on her body. I observed [REDACTED]'s face to have blood on it from superficial lacerations on her left cheek. I also observed superficial scratches on her right shoulder and her left elbow. [REDACTED] refused medical treatment.

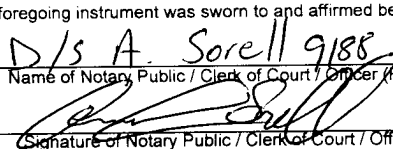
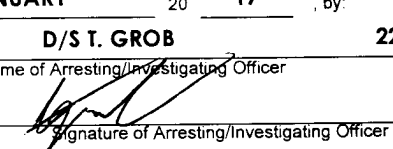

I then made contact with Lydia. Lydia's statements were consistent with those made by [REDACTED]. Lydia stated there was a verbal dispute between Alexa and [REDACTED] over bringing her home late. Lydia then stated Alexa attacked [REDACTED] without any provocation.

Due to my investigation, the statements made by [REDACTED], Lydia and Alexa along with the injuries observed from the incident, I found probable cause to arrest Alexa Perry for simple battery (domestic) as per F.S.S. 784.03(1)(A)(1).

Alexa had her two children in her vehicle, her husband was out of town, and there was nobody to watch her children. Also, Alexa does not live in the same residence as [REDACTED]. Due to all of these circumstances, I will be filing for a warrant for the arrest of Alexa Perry in lieu of making an arrest on scene.
