On the 26 day of January, 2017 at 09:31 (Specifically include facts constituting cause for arrest.)										
On 1/19/2017, at 1344 hours, I was dispatched to 6287 Riverwalk Ln, #3 in response to a suspicious incident. Upon arrival, I made contact with W/F Gail Freese, 6/11/1953. Freese advised she worked for the Riverwalk HOA, and was made aware of feces left on a car overnight. Freese found the feces on a 2015 Charger belonging to W/M Ronald Perholtz, 1/15/1948. Freese stated she cleaned the vehicle off in order to prevent damage. She then reviewed the surveillance video and noticed a male, whom she recognized as W/M Alexander Ankudinov, 5/30/1956, depositing the feces on the vehicle. The time stamp on the video indicated the incident occurred on 1/19/2017, at 0010 hours. Freese provided a sworn statement and informed me Perholtz was currently out of town and would not return for approximately 1 week. On 10/15/2016, I previously responded to the same address and made contact with Perholtz. On that date, Perholtz told me he discovered feces on his vehicle. Perholtz stated as the President of the HOA, he was being targeted by Ankudinov over disagreements with the HOA rules. Perholtz showed me video of a male he identified as Ankudinov depositing feces on his vehicle in that incident as well. After speaking with Perholtz, I made contact with Ankudinov. Ankudinov denied the incident, even after being told he was captured on video. I informed Ankudinov that any additional attempts to harass Perholtz, or deposit feces on his vehicle will result in Ankudinov being arrested for stalking. On 1/25/2017, Perholtz contacted JPD and requested I meet with him. Perholtz stated he reviewed the video from the second incident, and again recognized Ankudinov as the individual who deposited the feces on his vehicle. Perholtz also told me Ankudinov has been harassing him on a regular basis, including an incident in which Ankudinov nearly ran into a golf cart being operated by Perholtz before honking his horn. Perholtz said he was afraid that Ankudinov was going to run him over in that incident. He further stated based on Ankudinov's behavior, he is afraid that Ankudinov may escalate his behavior and harm Perholtz or other members of Riverwalk staff. Based on the above stated facts and circumstances, Alexander Ankudinov did
