PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
Sgt. Hennessy #210 observed a White Ford truck bearing FL Tag 255QLK going west bound on W. Indiantown Rd. Sgt. Hennessy stated he observed the truck swerving back and forth in his lane very quickly and effected another vehicle which had to hit their brakes suddenly to avoid a collision. Sgt. Hennessy noted that the vehicle continued to fail to maintain its lane. Sgt. Hennessy conducted a traffic stop by turning on his red and blue emergency lights and the truck came to a complete stop at the Shell Gas Station in Jupiter West Plaza located at 6671 W Indiantown Rd. Sgt. Hennessy stated that upon making contact with the driver and sole occupant of the vehicle, who was positively identified as W/M Alexander C. Patapis (8/31/1995), he noticed that Patapis had slurred speech and was slow in responding to questions as well as requests. Sgt Hennessy noticed that Patapis had slow exaggerated movements. For further see Sgt. Hennessy #210 Supplemental PC Affidavit.

OBSERVATION OF DRIVER:

Upon making contact with Patapis I noticed he had droopy red bloodshot eyes and was slow at responding. I asked Patapis to step out of the vehicle to which he complied. While speaking with Patapis he was cooperative but not maintaining focus during the encounter. Patapis made very exaggerated movements and was fidgeting.

DRIVER'S STATEMENTS:

Patapis stated he had not been drinking and was driving utilizing his business purpose license to go to his house after meeting with his boss to complete work related paperwork. Patapis stated that he was not on any medication. Patapis stated he had a couple of leg injuries from a motorcycle accident to include ankle and knee issues. Patapis denied taking any medication while on scene. Post arrest Patapis spontaneously asked if Marijuana would show up in his system and also stated he had taken benadryl earlier in the night.

WALK & TURN:

Patapis was unable to maintain the starting position and used arms to balance. Patapis stated he understood the instructions. Patapis missed heel to toe on several steps and took too many steps. Patapis stepped off line. Patapis conducted an improper turn and did not walk back. When asked if Patapis understood the instructions he stated take nine steps. Patapis was offered to re start and have the instructions reexplained to which he requested. Patapis again did not maintain the starting position. Patapis took too many steps again and missed heel to toe on nearly every step.

ONE LEG STAND:

Patapis did not maintain the starting position and started early. Patapis stated he understood the instructions. Patapis lifted his leg and did not look at his elevated foot throughout the whole task as instructed. Patapis was wobbling and was struggling to maintain his balance. Patapis did not count as instructed.

FINGER TO NOSE:

Patapis did not maintain the starting position. Patapis stated he understood the instructions. Patapis made extremely slow and exaggerated movements to help him better touch the tip of his finger to the tip of his nose. Patapis touched the side of his nose on several occasions.

Patapis stated he understood the directions. Patapis sang his ABCs incorrectly. Patapis was swaying while standing still.
