Supplemental probable cause affidavit On Tuesday, June 25, 2019, at approximately 19:30 hours, while I was in my marked PBSO vehicle, and while I was working an off duty detail at the Florida Fairgrounds located at 9067 Southern Blvd, in the unincorporated West Palm Beach, FL 33411, I was flagged down by an employee stating they needed law enforcement assistance due to a belligerent male who was attempting to drive a vehicle with obvious signs of impairment. I was transported by the fairgrounds security staff on their mobile Kart to the location where the vehicle was located (lot # 3). Upon my arrival I saw a black 2013 Toyota Camry with Florida license plate number # Z25- DFH, which was on and had its reverse lights on. I approached the front driver's side, and immediately was able to smell the odor of unknown alcoholic substance. I told the driver to place his vehicle on park and to turn off the vehicle. The male placed the vehicle on park but did not turn it off. I asked the driver several times to provide me with his driver's license. The driver did not provide me with his information right away. The male took his phone out and started to take pictures of me prior to giving me his name or any type of identification. While I was talking to him I was able to observe numerous open containers all over the vehicle's floor board. Moments later he provided me with his driver's license. The male was later identified by his Florida Driver's license as white male Alexander Belanger (DOB 12/07/1989). As I was talking to Belanger I observed his eyes appeared to be red and glassy. I observed that he was slurring his words, asking for my badge and ID number, which was given to him several times. As Belanger was giving me his license his arm appeared to be shaky and was not able to reach my hands. I proceeded to reach for his license and called for an on duty PBSO DUI unit so he could continue with the investigation due to obvious signs of impermanent. While waiting for DUI enforcement, Belanger stated that he needed to go to the bathroom. He was told not at the time due to him being detained at the time due to an impaired driving investigation. Belanger continued to tell us (Law Enforcement) that he needed to "pee". He proceeded to open his vehicle's door and exit the vehicle. While he was standing, outside of the vehicle, I observed that he was not stable on his feet as he was swaying back and forth. Due to Belanger being uncooperative and not following lawful commands to stand still I proceeded to place him in handcuffs with the assistance of D/S Josef ID # 25445. As he was being placed in handcuffs, he proceeded to tense his body up and clinch his right fist. I quickly locked the handcuffs. The handcuffs were double locked and check for proper fit and tightness as well. I made Belanger sit on the ground, so he could not get hurt by falling to do his instability of his feet. Once he was sitting down Belanger started to urinate on himself. It should be noted that the defendant contained to use derogatory terms towards law enforcement such as "fuck heads, retards, Captain wiener, bitch ass nigga" and more. He also asked if we (Law Enforcement) were going to "shoot him". Moments later Investigator Schaefer ID # 8777 arrived on scene and was able to take over the impaired driving investigation. All audio was caught on D/S Josef ID # 25445 in car video which later was tagged and placed into evidence through the inter-grated device called YAP. Therefore through the actions of Belanger, I find additional probable cause to arrest Alexander Belanger with the violation of Florida state statue of resisting an officer without violence. FSS: 843.02. Alexander Belanger did unlawfully resist, obstruct or oppose D/S E. Davalos ID # 24107, a law enforcement officer of the Palm Beach County Sheriff's Office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. (1 DEG MISD).

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 06/25/2019 at approximately 19:50hrs, I was called to the scene of a traffic stop at the South Florida Fair Grounds (Gate 12) which is located at 9067 Southern Blvd, which is located in unincorporated West Palm Beach, Palm Beach County, Florida. I arrived at the scene at approximately 20:03hrs. D/S /S EDUARDO DAVALOS #24017 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had stopped the defendant's vehicle, a 2013 black Toyota Corolla bearing FL tag Z25-DFH, because he was flagged down by Fairgrounds employee who stated that the driver was belligerent and attempting to drive away. D/S Davalos noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. D/S Davalos identified the defendant, to me, as the driver & sole occupant of the vehicle, at the time of the stop.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by his Florida driver license as "ALEXANDER MICHAEL BELANGER", I immediately detected an obvious and strong odor of an unknown alcoholic beverage emanating from his person and face area. This odor intensified as I spoke to Belanger. Belanger had glassy, glazed, and blood shot eyes. Belanger's speech was extremely slurred, slow, thick, and at times difficult to understand. Belanger's movements were slow and deliberate, and lethargic with poor coordination when attempting to stand and while being escorted to my patrol vehicle. Belanger was wearing a black tank top, green shorts, and black shoes. All the clothing appeared disheveled. Belanger was handcuffed and seated next to his vehicle due to him not complying with deputies on-scene.

DRIVER'S STATEMENTS:

Pre-Miranda: none

Belanger refused to speak on video, only nodding his head to certain questions. Belanger declined to submit a breath sample and then stated "Plead the 5th" after Implied Consent was read and explained to him. Belanger declined to participate in the Q&A portion of the interview.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emanating from his person and face area which intensified as I spoke to Belanger.

GENERAL OBSERVATIONS

SPEECH: Belanger 's speech was extremely slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: emotional, annoyed, pleading, belligerent, threatening, insulting

CLOTHING: black tank top, green shorts, and black shoes

MEDICAL/OTHER: As stated by Belanger, "I have mental problems"
