On 02/11/2017, at approximately 0152 hours, I responded to 10580 Forest Hill Blvd, Wellington, FL, 33414 in reference to a Traffic Stop, conducted by D/S Schneider #8723.

Upon my arrival, I made contact with Alexander Paul Scheible. Immediately I observed a large amount of white powdery substance on both of Alexander's nostril openings/upper lip area. Alexander seemed anxious, and was making irrational movements with his hands when I stated that I observed the white powdery substance. From my training and experience I recognized this white powdery substance to have a high probability of being cocaine. I then ordered Alexander to exit the vehicle, and placed him in handcuffs, for temporary detainment while I continued my investigation.

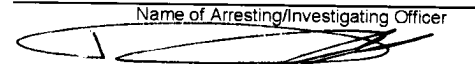
Upon searching the front drivers side of Alexander's 2011 White BMW bearing FL tag #EXM-B17, I observed a clear plastic bag in plain view, between the driver seat and the center console, containing a white powdery substance I believe from my training and experience to be Cocaine. Upon completion of my vehicle search, I tested the contents of the clear plastic bag, which field tested positive to be Cocaine, using a PBSO Issued Cobalt drug test kit.

Due to the above facts, Probable Cause exists to place Alexander Paul Scheible under arrest for Possession of Cocaine pursuant to F.S.S. 893.13(6)(a).

On February 11, 2017 I, Deputy Schneider, was conducting stationary radar on Forest Hill Blvd and Wellington Green Drive. The posted speed limit in this area is 45 mph. At approximately 0150 am I observed a vehicle approaching me at a high rate of speed. I visually estimated the speed to be approximately 75 mph. I then activated my radar which produced an audible Doppler tone and a digital reading of 76 mph. I activated my emergency lights and initiated a traffic stop. The vehicle came to a stop at 10580 Forest Hill Blvd. Deputy Septien ID 20750 responded as a back up deputy. Upon contact I introduced myself as Deputy Schneider of the Palm Beach County Sheriff's Office and explained the reason for the stop. I immediately noticed the driver had a white substance surrounding both opening of both of his nostrils and he seemed anxious. Due to my training, knowledge and experience I immediately recognized this as an indication of possible cocaine use. I requested his Drivers License, insurance and registration to which he complied. I identified the driver as Alexander Schelble and ran his DL through PBSO dispatch which revealed nothing significant. Due to the white substance around the opening of Mr. Schelble coupled with his anxious behavior and the speed at which he was driving he was requested to exit the vehicle and temporarily detained. Deputy Septien explained that due to the plain view of the white powdery substance on his nose he was going to search his vehicle for evidence of contraband. When this was explained to Mr. Schelble he denied any narcotics use and wiped his nose on his shirt sleeve leaving a white residue on the shirt. Deputy Septien then searched the vehicle see his report for further. I then issued a citation for speed, 76 in a 45 and turned this case over to Deputy Septien. This ends my involvement in this case.
